The Society was established by the enactment of the Architects (Landscape) Act in 1968 as a self-governing professional organization whose objectives include the furtherance and maintenance of proper standards of professional practice.

BCSLA Affiliate: Any individual, organization, institution, or business with an affiliation to the Principles and Practice of Landscape Architecture may apply for recognition as an Affiliate of the Society. Persons and organizations working in fields related to Landscape Architecture that wish to advise our Members of their services can become an Affiliate of the BCSLA.

Upon acceptance by the Board of Directors and payment of all fees when due, such individuals are entitled to use the designation "**BCSLA Affiliate**," receive all general communications of the Society, attend general meetings as a non-voting Affiliate, and attend continuing education programs and sessions at BCSLA rates.
