2012 BCSLA Professional Dues

In accordance with BCSLA Bylaw 3.84: *An annual increase in Member dues will be equal to the annual rate of inflation based on the Consumer Price Index, across all categories, every year rounding up to the nearest dollar. The amount of such fees may vary between categories of Members, and categories of Associates and Affiliates.*

At the October 25, 2011 BCSLA Board of Directors meeting it was reported that the Bank of Canada established the CPI as 2.9% and the Board approved a Motion to increase the BCSLA portion of the dues by 3%.
