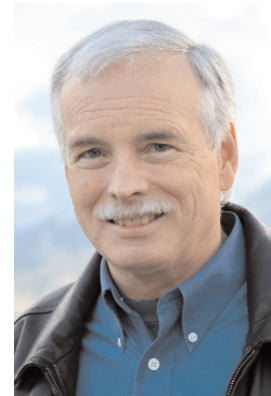
INCONVENIENT
