

## BRIDGE TO REGISTRATION

**NOTE:** The information below applies to British Columbia only. Entry standards vary from one jurisdiction to another.

All Landscape Architects in BC are Members of the British Columbia Society of Landscape Architects (BCSLA). An applicant from another jurisdiction other than those in North America, seeking enrolment in the admissions program, must deliver the following to the Registrar: a) petition for admission; b) certificate of character references; d) certificate of standing from each body regulating the profession of landscape architecture in each jurisdiction in which the applicant has been a member; e) proof of academic qualifications directly from the learning institution; f) declaration from a Principal who satisfies the standards required by the Credentials Committee, describing the experience of the applicant; g) payment in full of all fees, including investigation fees for an extra-jurisdictional review, admission fees, and other reasonable assessments; and h) proof of satisfactory training and knowledge of the English language, and any other information and documents required by the Credentials Committee.

| <p><b>5 a)</b> Applicant successfully completes LARE.</p>   | <p><b>5 b)</b> Applicant completes minimum two years of documented experience in landscape architecture.</p>  |
| <p><b>6)</b> Applicant makes an application to the Credentials Committee to become a Member.</p>  |   |
| <p><b>7)</b> Credentials Committee recommends Applicant to the Board of Directors for Oral Exam.</p>  |   |
| <p><b>8)</b> Board of Directors accepts application to go before the Board of Examiners.</p>  |   |
| <p><b>9)</b> Applicant successfully passes the Oral Exam by demonstrating a minimum understanding of the legal and ethical requirements of Landscape Architects.</p>                  |   |
| <p><b>10)</b> Board of Examiners accepts Applicant as a Member. Registrar notifies the new Member.</p>  |   |
