Professional dues are due annually in advance, i.e., by **December 31** of the preceding year. Any Member, Associate/Intern or BCSLA Affiliate allowing dues to become delinquent shall be assessed a penalty amounting to 15% of the annual dues.

## Payment Options

Due to the Canada post-strike this year, we recommend paying by EFT or with credit card.

**a) Using Electronic Funds Transfer (EFT) via Interac (Canada Only):** Log on to the website of your financial institution follow the prompts for Interac transfers. **You must quote your invoice number as payment reference.** Send transfers to: [admin@bcsla.org](mailto:admin@bcsla.org). **CAUTION:** Double-check that the email address is correct.

**b) Credit Card:** The BCSLA now accepts all major credit cards. To pay by credit card, call the office on 604-682-5610. A processing fee of 2.99% + .25 cents applies on all credit card payments.

**c) Cheque:** If you pay by cheque, please contact [membershipservices@bcsla.org](mailto:membershipservices@bcsla.org) and let us know you've opted for this payment method. Cheques should be made payable to "The BC Society of Landscape Architects" and sent to the BCSLA office in Canadian funds. Be sure to pay the full amount of the invoice, including the GST.

## **2025 CSLA Dues**

Curious about CSLA dues? Once you become a member of a component association (the BCSLA), you automatically also become a member of the CSLA, the national association body. The BCSLA collects annual dues on behalf of the CSLA. These dues are based on the needs of the CSLA and are therefore regulated by the CSLA Board. An agreement between the CSLA and the BCSLA outlines the requirement of the BCSLA to invoice members the annual CSLA dues.

Together, the CSLA and the provincial, territorial and regional component associations form the family of service organizations which defend, promote, advocate, celebrate, support, develop, regulate, educate, set standards for and inform the profession of landscape architecture.

Both the national and provincial, territorial and regional associations play a distinct and important role in the profession, and we work together to ensure we meet our collective objectives. Furthermore, as some of the component associations move towards practice act legislation, their roles will become more defined based on their new legislation, and the CSLA will be there to take on activities which they will no longer manage.

This will vary from jurisdiction to jurisdiction, but could include important advocacy and celebration initiatives, and the ability to speak to national, regional, provincial, territorial or municipal policy through statements and positions.
