### **2019 BCSLA ANNUAL GENERAL MEETING MINUTES**

The British Columbia Society of Landscape Architects 2019 Annual General Meeting was held at 2:30 pm on April 27, 2019 at the Coal Harbour Ballroom, Coast Coal Harbour Hotel, 3rd Floor 1180 West Hastings Street, Vancouver, BC.

1) Welcome & Introductions, Stephen Vincent, President: Stephen introduced himself and thanked Members and Associates for their attendance and reminded everyone to sign in. He reported that eligible Members would receive a voting card once they had signed in. Stephen introduced Eli Mina, Msc, PRP, the Registered Parliamentarian who would facilitate the meeting. He introduced Mahmoud Virani, the principal of Mahmoud Virani Inc, the firm that conducted the annual audit and noted that Mahmoud would answer questions related to the audit. The BCSLA Board of Directors introduced themselves.

Stephen noted that the BCSLA acknowledge and respect that this meeting is held on the unceded Coast Salish territories of the xwmə0kwəyəm (Musqueam), Skwxwú7mesh (Squamish), and səlilwəta?t (Tsleil-Waututh) First Nations.

**2) Declaration of a Quorum: Jacqueline Lowe, Registrar:** Jacqueline reported that in compliance with BCSLA Bylaws, the 2019 AGM Notice, Director and Committee Reports and all other documents were circulated by mail and email on March 27, 2019, four weeks in advance of the meeting. The documents were also published on the website. Copies of the 2018 audited financial statements and the 2019 AGM package were available at the door.

There were 460 eligible voting Members including: 362 Registered Landscape Architects, 15 Landscape Architect Members, 64 Inactive Members and 19 Retired Members. BCSLA Bylaws require that a quorum of twenty (20) voting Members be present, and the quorum requirement was met as there were 84 voting Members in attendance at the meeting. One BCSLA Intern was also in attendance.

Eli Mina explained the main rules for the meeting.

3) Approval of the Agenda, Stephen Vincent: The Agenda was reviewed.

MOTION #1: It was moved and seconded that the 2019 AGM Agenda be adopted as circulated. CARRIED

4) Adoption of Draft 2018 AGM Minutes, Stephen Vincent: The 2018 Minutes were reviewed.

MOTION #2: It was moved and seconded that the Minutes of the 2018 AGM be approved as circulated. CARRIED

**5) Officers Reports, Stephen Vincent**: The Officers had provided written reports that were included in the AGM package. Questions were invited from the floor.

**a. President's Report, Stephen Vincent:** Stephen reported that his written report was included in the AGM package and invited feedback.

- **b. Registrar's Report, Jacqueline Lowe:** Jacqueline reported that the written Registrar Report was included in the AGM package and invited feedback.
- **c. Treasurer's Report, Wai-Sue Louie:** The 2019 budget was restrained due to the current economic climate. The budget addressed the uncertainty related to hosting the 2019 CSLA Conference in BC. BCSLA and CSLA have signed an agreement to share risks and rewards from the conference. Finances will become clearer after the May event. Also, the BCSLA Board of Directors launched the BCSLA Five-Year Strategic Plan in 2017. The 2019 Adopted Budget was aligned to allow BCSLA volunteers to work on the tasks that were developed in that process. It was reported that there may be some costs related to the Professional Governance Act-2018 in the future.
  - i. **2018 Audit:** Mahmoud Virani reviewed the 2018 audit in detail. He reported that while page 5 of the audit shows a deficiency of \$12,418 the operations side of the audit shows a slight surplus in the amount of \$13,654.

**MOTION #3:** It was moved and seconded to adopt the financial statements as circulated.

#### ii. Appointment of the Auditors:

MOTION #4: It was moved and seconded that Mahmoud Virani Inc. be appointed as the BCSLA auditor for 2019.

Wai-Sue thanked Mahmoud and his staff for their work on behalf of the BCSLA.

iii. 2019 Approved Budget: It was reported that the 2019 Budget was approved by the BCSLA Board of Directors and questions were invited. A suggestion was made to consider increasing BCSLA scholarships to support emerging professionals. A related item to the budget is included in the Special Resolution, Proposed Landscape Architecture Project V Funding, which was scheduled to be discussed later in the meeting.

MOTION #5: It was moved and seconded to adopt the Officers Reports as presented. CARRIED

6) Directors Reports, Stephen Vincent: Stephen noted that written reports were included in the AGM package and invited questions from the floor. There were no questions.

7) Committee Reports, Stephen Vincent: Stephen noted that written reports were included in the AGM package and invited questions from the floor. There were no questions.

**8)** Special Resolution #1, Stephen Vincent: Notice of Special Resolution #1 was circulated by mail and email. It was also posted to the BCSLA website on March 27, 2019, more than four weeks in advance of the 2019 AGM. The complete Special Resolution #1 was included in the AGM package. In accordance with BCSLA Bylaw 3.26, Special Resolutions require a majority of 75% to pass or fail.

In November 2018 the BC Government passed *Bill 49-2018: Professional Governance Act (PGA)*, which will consolidate government oversight of the five professional regulators representing engineering and geoscience, forestry, agrology, applied biology and applied science technology under a new Office of the Superintendent of Professional Governance (OSPG). Many of the details are being worked through at the legislative level and at the time of publishing it is not known how Landscape Architects will be represented under the new Bill. The BCSLA recognizes the benefits of government oversight and the addition of new regulatory tools to protect the public interest and we are working to determine the impact of the legislation for our profession.

The BCSLA established the Regulatory Review Task Force to address issues related to Bill 49. While the details of changes in governance are yet to be fully understood it is anticipated that BCSLA may be invited by the Government of BC to join the other professions under the Office of the Superintendent in three to five years. We have engaged legal and government relations consultants to provide guidance as required. Volunteers are working to:

- a. Review BCSLA constating documents including: Bylaws and Standards of Professional Conduct and Practice in consultation with the BCSLA Membership.
- b. Develop supporting material to provide stakeholders with information on landscape architecture in BC
- c. Understand if there is potential that landscape architects might be excluded from certain work.
- d. Determine how the BCSLA's governance may change.

In March 2019 BCSLA responded to the Engage BC initiative on important issues that will form the framework of the changes to regulations. This includes regulation of firms, competency declarations and conflict of interest declarations and independent practice rights of professions.

Government can designate other professional regulators as regulatory bodies under the PGA, following an investigation and recommendation by the Superintendent. The PGA will also allow the Superintendent to make recommendations on whether to amalgamate existing regulatory bodies. Detailed discussion followed regarding the risks and rewards joining the PGA. It was agreed by consensus that the BCSLA should continue to conduct research to better understand the implications of the PGA.

It was reported that there was \$28,386 in the Special Levy Account (\$7,708 in the Chequing Account and \$20,768 in a Term Deposit that will mature on May 23, 2021). These funds must only be used for initiatives consistent with the Landscape Architecture Project and can only be released from the account by a Special Resolution as approved by the membership.

**MOTION #8:** It was moved and seconded to adopt the Special Resolution #1 as circulated. The vote was facilitated by Eli Mina using voting cards. Eli declared that:

#### Special Resolution #1

**On April 27, 2019 it was RESOLVED** that the BCSLA allocate a maximum of \$28,000 from the Special Levy fund for the period 2019 to 2021 in support of the Landscape Architecture Project V. The funds will be used at the discretion of the Board of Directors to conduct a review of Bill 49 and the issues related to: Architects (Landscape) Act, Bylaws and Standards of the Profession, labour mobility and governance. Funds may also be expended for contractors to provide legal and government relations advice as required.

9) Elections: Stephen invited Eli Mina to facilitate the elections. Eli provided guidance on election procedures.

**Election of Officers, Stephen Vincent/Eli Mina:** It was reported that President-Elect Yolanda Leung stepped down for personal reasons. Jacqueline Lowe allowed her name to stand as President to fill the vacancy created by the resignation. Jacqueline also stepped in to serve as Interim Registrar prior to the AGM earlier when Patrick Harrison resigned earlier in the year. The Registrar position was open for nominations. Al Neufeld has allowed his name to stand for a two-year term as Registrar.

**President:** Jacqueline Lowe allowed her name to stand for a two-year term as President for one year and Past President for one year. Nominations were invited from the floor. There were no further nominations and Jacqueline was acclaimed as President. She reported that she would continue to work on the Bylaw Review, Professional Governance Act, and other important projects. Jacqueline invited Members and Associates to contact her anytime with input or questions.

**President Elect:** Erik Mustonen allowed his name to stand as President Elect. Nominations were invited from the floor. There were no further nominations. Erik Mustonen was elected by acclamation to the position of President Elect and he addressed the members noting that as PPR Chair he would assist Committee volunteers on several initiatives including the Regulatory Review Task Force initiatives.

**Registrar:** Al Neufeld allowed his name to stand as Registrar for a two-year term. Nominations were invited from the floor. There were no further nominations. Al Neufeld was elected by acclamation to the position of Registrar, and he addressed the members noting that he had served in several roles on the Board and that he was looking forward to continuing to work on behalf of Members and Associates.

**Directors**: Teri Cantin, BCSLA Interior Chapter Chair, Kathy Dunster, CSLA Representative, Liane McKenna and Donna Rodman had one year remaining in their terms as Directors. Debra Barnes and Jordan McAuley completed their Directors terms and would step down. Illarion Gallant, BCSLA Vancouver Island Chapter Representative, completed his two-year term and allowed his name to stand again. Stephen thanked everyone for their dedication and service to the Society and the Members.

There were two vacancies for BCSLA Directors. Somaye Hooshmand and Scott Watson allowed their name to stand as Directors for a two-year term. Nominations were invited from the floor. There were no further nominations. Somaye Hooshmand and Scott Watson were elected by acclamation as BCSLA Directors.

**Vancouver Island Chapter Representative:** Illarion Gallant allowed his name to stand as the BCSLA Vancouver Island Chapter Representative. Nominations were invited from the floor. There were no further nominations. Illarion Gallant was elected by acclamation to the position of Vancouver Island Representative.

It was noted that the following non-voting positions are appointed by the BCSLA Board: Susan Herrington is the UBC Representative, and Alix Tier is the Student Representative. Susan would continue in her position. Alix will be succeeded by a nominee who will put forward by the UBC SALA Students Association. The BCSLA Intern and Associate Representative will also be appointed following the AGM. Stephen thanked Emily Hamilton who served as the BCSLA Intern and Associate Representative for several years. Thanks also to Alix for her service. Stephen thanked all candidates who allowed their name to stand. He also thanked the volunteers for their assistance with the election. Stephen congratulated all the Directors. He thanked Eli Mina for his advice and guidance.

Stephen invited Jacqueline to receive the BCSLA Talking Stick and Jacqueline assumed the Chair. She thanked Stephen for his dedication to the BCSLA and his hard work. Jacqueline thanked the Members and Associates for their confidence in her and noted that she would continue to work hard on behalf of all BCSLA Members and Associates.

10) New Business, Jacqueline Lowe: Jacqueline invited new business.

**Continuing Education (CE) Committee, Kathy Dunster:** Kathy encourage Members and Associates to join the CE Committee. Volunteers continue to bring good ideas for professional development opportunities and events.

**11) Adjournment, Jacqueline Lowe:** There being no further new business, Jacqueline thanked everyone for attending and encouraged Members and Associates to be involved as a BCSLA volunteer as it is a rewarding experience.

MOTION #9: It was moved and seconded to adjourn the 2019 Annual General Meeting of the BC Society of Landscape Architects.

The meeting adjourned at 3:30 pm.

### **PRESIDENT'S REPORT**

#### Welcome

To start off the 2019 to 2021 summary, I would like to say thank you for taking the time to review this package and attend our first virtual AGM. The world and local events that have happened between 2019 to current day have been immense and transformative for us as people and professionals, and for this Society. Enclosed is a summary of some of the key topics that have been in focus for the Board of Directors during this time. Please feel free to connect with me if you have any questions or would like to know any further information, and I look forward to any questions or comments you may wish to express at our upcoming AGM.

#### **Strategic Update**

Our existing strategic plan is a five-year vision, with the first three years identified for core action. The Board had the responsibility to review the progress to date and determine the priorities for the remaining two years of the vision. Towards the end of 2019, and in early 2020, our Board of Directors met to evaluate and discuss the success of the work to date. We met to workshop prior to the start of our monthly meetings and identified additional specific action items and goals based on existing vision, and emergence of need. Several of these key priorities were met through the 2020 calendar year, and at the start of 2021 we commenced an additional review of the Strategic Plan to provide a Strategic Update report, included with this AGM package. Some of the key items achieved included:

- Development of a New Board Member Welcoming Package, which included role and responsibility definitions, conduct and emergency protocols
- A condensed Emergency Plan for managing short term emergencies (0-3 months) where opportunity to access the office may be limited. This also included development of protocol and security measures in emergency scenarios.

• Start of a framework for an office staff Succession Plan

In 2022, the Board of Directors will need to engage members in discussion for a new vision and plan moving forward. The timing of this new visioning exercise will occur at a key moment when we will have a better sense of the status of BCSLA's application to join the Professional Governance Act. As you review the Strategic Update report, please feel free to share comments and feedback with the Board at the AGM. I would also like to thank Liane McKenna, Donna Rodman, and Devon Francis for their support in the development of the report.

#### **Office Renewal**

In early 2020, the office lease was completing its cycle. The projected increase of costs was leading to strategic discussions on location. However, the emergence of COVID-19 impacted the commercial real estate market and a new opportunity emerged to remain in the same location at a very competitive rate. A ten-year lease was signed to keep the office in the Marine Building. With the upcoming office fund account reaching maturity in 2022, the membership will have the opportunity to determine how to best utilize the savings in the future.

#### **COVID-19 Response**

The Board meetings converted to be fully virtual in early 2020 with the emergence of new protocols and restrictions related to COVID-19. The BCSLA staff worked remotely for most of 2020. Several responses occurred to support Board function, staff safety, and membership reach out at the onset of the pandemic. Some of the highest priorities included:

 Cancellation of the summer 2020 AGM and conference, in accordance with provincial health guidelines and emergency legislation that allowed for delay of AGMs

### **PRESIDENT'S REPORT (CONT.)**

- Restructuring the forecasted budget of 2020, based on the removal of the conference and AGM
- Motion to hold the Board in place (as the AGM could not occur) instead of rotating in 2020. This has led to the need of a double rotation at this AGM, except for the president roles, in accordance with review by our Parliamentarian, Justin Schmid
- Development of new staff safety protocols, including review of building safety protocols
- A new Work from Home policy, based on recommendations from WorkSafe BC
- Computer and virtual infrastructure upgrades needed to support virtual and commuter work-styles
- BCSLA Friday File announcements and updates providing information on provincial guidelines
- Research of virtual AGM platforms and preparation for the 2021 AGM

#### **Diversity, Equity and Inclusion**

"The BCSLA Board of Directors is engaging in ongoing conversation, both internally and externally, to determine our actions moving forward. We at the BCSLA are committed to take action to support the membership in any way possible as a regulatory body. Between the BCSLA, CSLA, the academic community, public and private practice, and advocacy networks, we all have an important part to play in dismantling racism, colonialism, and discrimination within the field of landscape architecture and by extension the design community. What remains important right now is that we provide a platform for all bodies to intersect and communicate so that we are not duplicating, but rather completing a complementary series of actions and initiatives moving forward."

The above excerpt came from a statement from the board as a result of a workshop and discussion on ways to address the global movement that was amplified in 2020. Focus on diversity, equity and inclusion occurred through Board meetings, member discussions, and developing plans through the increased call to action. Some of the developments that occurred within the BCSLA are as follows:

- BCSLA members that were part of a collective signed call-to-action of the CSLA/OALA were invited to discuss observed systemic oppression, bias, and racism experienced and observed in practice in BC. Two virtual meetings occurred to begin an initial conversation. There was discussion on ways to attract diversity and intersectionality within the profession through early education and access to knowledge about landscape architecture (i.e. at the elementary and high school level) as a chosen profession.
- The BCSLA provided a \$5,000 contribution towards the CSLA retaining a consultant for the development of a framework focused on diversity and inclusion. The framework would be provided in two formats: first, as a National plan for CSLA to follow through the JEDI (Justice, Equity, Diversity and Inclusion) committee, and second, in a format suitable for a component organization and regulator to adapt.
- The result of the above-mentioned commitment, as well as a commitment for measurable and provincially focused objectives led the board to pass a motion to form a DEI committee within the BCSLA.
- In alignment with a request by CSLA that all boards receive Indigenous training, the board passed a motion to find a local consultant that would focus on educating both the Board and core standing committee members. After initial research, a consultant team was hired and the first training session will occur in September 2021, with Sky Spirit Studio + Consulting.
- The training commencing in the fall will be the first of several opportunities being planned.
   Discussions have also occurred on Continuing Education opportunities and training for members.

### **PRESIDENT'S REPORT (CONT.)**

Funding was also applied for to support 2021 actions, and the REFBC (Real Estate Foundation of British Columbia) has donated \$5,000 from a Small Contributions Fund and expressed interest in collaborating with the BCSLA on similar initiatives in the future. The REFBC has supported many BCSLA programs, services and activities for many years and we look forward to continuing our relationship with them.

In relation to the work of the Credentials Committee, the BCSLA was successful in receiving funding from the CAIF (Credentials Assessment Improvement Fund), from the BC Ministry of Municipal Affairs for a Pathway to Accessible Licensure Project. The objective of the application was to receive funding support to update the BCSLA's existing multilingual webpages, create a secure online application process, and create a pathway to accessible licensure for application review. A component of the project also includes gender-based analysis+ (GBA+), which is utilized through the information survey. The 2020-2021 funding received was in the value of \$20,000. Application for a second part of funding is underway. The request for 2021-2022 is in the value of \$33,000. We are thankful for the support of Ministry staff and the team at Luna Design for their role in the success of this project.

**New DEI Task Force:** The result of the developments between 2020 through 2021 have led the Society to create a new task force focused on Diversity, Equity and Inclusion. The task force will work directly with the Board of Directors in the development of strategy based on the following:

- Use of the CSLA and Component focused framework, by adapting it and expanding it to suit the needs specific to British Columbia, and BCSLA as a regulator
- Engaged discussions with the CSLA Committee and

Task Force chairs to understand national objectives and where support could be applied in a local context through BCSLA

- Training on Indigenous rights and history
- Engagement and consultation with the membership

**Call for Volunteers:** The call for volunteers is officially open. Please contact the BCSLA office and inform Tara or Devon of your interest to join the taskforce. The call for volunteers will be open through the summer of 2021, however, anyone can join any taskforce or committee at anytime. A follow-up engagement session with members wishing to join the committee or speak in a precursory level about goals and objectives are welcome to join an upcoming Town Hall. This discussion is intended to be an orientation opportunity for new task force members to become acquainted and develop a sense of core interests from the membership.

#### Professional Governance Act and the Regulatory Review Task Force (RRTF)

By now the membership would have received opportunity for orientation about the Professional Governance Act, through the Mandatory Continuing Education Webinar. Following the 2019 AGM, the following actions occurred to lead the Society to this place, through the collaborative efforts of the Regulatory Review Task Force and Board of Directors:

- The 2019 AGM included a pre-AGM session for orientation about the Professional Reliance Review, Bill 49, and the creation of the Office of the Superintendent of Professional Governance (OSPG) and the Professional Governance Act (PGA). A Special Project account was approved via motion at the AGM to support consulting costs needed to research the opportunity of BCSLA to join.
- The regular 3-year Bylaws review was placed on-

### **PRESIDENT'S REPORT (CONT.)**

hold in recognition of the application to the PGA. The Bylaws Committee will still meet through 2021 to review the existing bylaw watch-list and anticipate additional changes required.

- Counsel Public Affairs (CPA) was retained in fall of 2019 for an 8-month contract to provide general intelligence about areas of research, fit, and approach for applying to the PGA. CPA's contract was renewed in 2020 for the balance of the year on an additional 6-month contract. The value of services equated to \$20,300 for each contract.
- Through initial contact by Counsel Public Affairs, the BCSLA connected with the OSPG in early 2020. A few general discussions occurred in spring and early summer regarding the profession of landscape architecture and BCSLA's interest in joining the PGA
- In summer of 2020, the Board passed a motion in favour of applying to the PGA. A letter of intent was submitted to the OSPG.
- Based on early timelines for enactments of parts of the PGA, the OSPG was planning to be able to receive an application in fall of 2020. However, the BC Election became the focus within government during this time.
- Discussions with the presidents and CEOs and executive staff with the other regulatory bodies currently in the PGA (or being added to the PGA) occurred in fall and winter of 2020.
- In early 2021, discussions resumed with OSPG, and it was confirmed that it was an appropriate time to apply.
- The BCSLA initial draft application is complete and currently under review.
- Members will receive additional Town Hall opportunities in 2021, and FAQ and other important information about the outcome of the application will be made available.

I would like to thank the RRTF team for their vast contributions. The team includes **Adrienne Brown** 

(Co-chair), Frank Basciano, Catherine Berris, Larry Diamond, Cynthia Girling, Al Neufeld, Meredith Mitchell, Erik Mustonen, and Donna Rodman. I would also like to extend special thanks for support and contributions from Tara Culham, Devon Francis, David Bieber, Illarion Gallant, Doron Fishman, David Fushtey, Erik Lees, and Stephen Vincent.

#### Closing

In closing, I would like to extend thanks to the Board of Directors, our outgoing Past President Stephen Vincent, Tara Culham and Devon Francis, Committees and Sub-Committees, and Task Force members for your time and dedication to the Society, and your collaboration through 2019 to 2021. I would also like to thank the membership for your trust in me as your president for this double term. I believe that we all came together and supported each other, held space for the health and safety and well being of each other and our peers, and conducted ourselves with an openness to recognize how much further our profession and this Society can advance in the years moving forward.

I would also like to thank members from the abovementioned groups and additional colleagues in the Society for your time and connection over the past years. Getting to hear how people were doing, sharing stories and points of connection, and sharing critical thinking on ways to move the profession forward were day-to-day aspects of this role that I will never forget. As your Past President for 2021-2022 I will remain committed to finding space for our Society to connect in this capacity as we approach opportunities to meet in person.

### **PAST PRESIDENT'S REPORT**

#### **Board of Examiners**

The BCSLA Board of Examiners consists of the BCSLA President, the BCSLA Past President, and four or more persons appointed by the Lieutenant Governor in Council for British Columbia. The Board of Examiners is empowered by the Architects (Landscape) Act RSBC 1996, Chapter 18, S8 in order to uphold public health, safety and welfare as it relates to the professional practice of landscape architecture in British Columbia. The role of the Board of Examiners is to set and administer the examinations necessary for the registration of Members in the Society and to review the applicant's qualifications and to determine acceptability.

In 2019 The BC Society of Landscape Architects welcomed 31 new Registered Landscape Architects as a result of five administrations of the Board of Examiners. Additional administrations were added to address a backlog of candidates due to delays in examiner appointments at the government level. Three exam administrations were held over the summer and fall in 2020. In 2020 19 new Registered Landscape Architects and two new Landscape Architects were added to the Membership Roster. Some examinations were administrations in 2021. The exams will be four exam administrations in 2021. The exams will be held on a virtual platform until it is safe to gather in person.

The Board is comprised of qualified examiners including **Stephen Vincent**, Past President and Chair; **Jacqueline Lowe**, President; **Catherine Evans** is the person nominated to represent the public interest; **Susan Herrington**, was nominated by the head of Landscape Architecture program of the University of British Columbia; **Matthew Soules**, was nominated by the School of Architecture and Landscape Architecture of the University of British Columbia and **Maria Valana**, nominated by Kwantlen Polytechnic University. **Al**  **Neufeld**, Registrar, is not a member of the Board of Examiners however does observe and provide support to the Board of Examiners during their deliberations, without participating directly in decisions of examination recommendations. We thank everyone for their dedication and expertise. All four appointments will be open for re-nomination in 2022.

Thank you to **Kathy Dunster, Greg Johnson, Thomas Llewellin, Patrick Mooney, David Thompson** and **Scott Watson** who filled in for Examiners who were unavailable. They graciously helped to ensure a full panel was on hand for all examination administrations. in the development and maintenance of proper standards of professional practice in landscape architecture in British Columbia.

#### **Board of Examiners**

After delays due to changing Covid-19 regulations and delays in the Examiner Appointment process at the provincial government level, nine administrations of the BCSLA Board of Examiners were held in 2019 and 2020. Please refer to the Past President's Report.

#### **Delinquent Dues**

As defined in our Bylaw 2.45, Members who fail to pay dues within 60 days of notification shall cease

to be a member of the Society. All dues are invoiced on November 30 and are payable by December 31 of the same year. In accordance with BCSLA Policy for Payment of BCSLA and CSLA Professional Dues the

- first notice to be sent January 15;
- second notice to be sent February 1 reminder that professional dues are in arrears and that if dues are not received, the person will cease to be a Member on such a date;
- third notice to be sent March 1 informing the member that they are a member Not in Good Standing.

Several new forms were developed in 2020 to be used for Members and Associates when they are requesting a change in status to assist in administration in keeping with standard accounting practices.

### Council of Landscape Architectural Registration Boards (CLARB)

The Registrar and the Executive Director represent BC at CLARB meetings that are held via teleconference, online and once a year in person. In September of 2019, AI and Tara represented BC at the CLARB AGM in St Louis. Missouri. The intensive discussions included licensure. LARE. foresight, DEI training and more. CLARB shared research and tools to support regulatory efforts and strategic planning. CLARB also organizes several online opportunities for Member Board Members and Member Board Executives to share information and experiences. The new CLARB CEO. Matt Miller was also introduced at this meeting. The 50th Anniversary CLARB AGM was cancelled due to Covid-19. An online Regional Meeting was held in February of 2021.

The CLARB Board of Directors concluded that the organization's current governance structure and processes needed additional flexibility. At the 2019 AGM a new governance structure was adopted that allows for more strength-based appointments on the Board of Directors rather only regional representation.

Al Neufeld was able to attend the 3-day NCARB (National Council of Architectural Registration Boards) training for new Member Board Members held in Washington DC in February of 2020. The costs were covered by CLARB. The training was informative on the various multi-disciplinary boards that make up the majority of regulatory governance in the US. This is more reflective of the model that the PGA has set up in BC and towards which the BCSLA aspires to become part of.

## Landscape Architectural Registration Exams (LARE)

The LARE is a four-part fully computerized examination designed to determine whether applicants for landscape architectural licensure possess sufficient knowledge, skills and abilities to provide landscape architectural services without endangering the health, safety and welfare of the public. It is prepared and scored by Council of Landscape Architectural Registration Boards (CLARB) in accordance with all current standards for fairness and quality of licensure exams.

For many years BCSLA has been recommending that CLARB identify more test centres in BC in order to accommodate candidates from across the province. In the past few years the number of test centres has increased from one to four. Testing centres are located in Burnaby, Surrey, Vancouver and Victoria. We will continue to encourage CLARB to open additional test centres across BC. In 2020, BC, Ontario and Alberta volunteered to test remote proctoring of Sections 1 & 2 of the LARE. The test was successful and remote proctoring of these sections is now available as an option to everyone taking the LARE for sections 1 & 2. It is anticipated the Sections 3 & 4 will be available via remote proctoring in 2022 if the current testing is successful.

#### LARE Resources

CLARB has provided sample questions and answers to help LARE candidates prepare for the exams. Several of the questions were retired from recent examination administrations. These were created to provide a sample of what candidates will experience when they take the LARE. Download the questions and other resources for free at www.bcsla.org. AALA, OALA and BCSLA have joined forces to offer online open LARE study sessions for up to 500 candidates. Thank you to Tamara Bonnemaison,

#### **BCSLA Website**

The online database is a powerful tool that is administered by staff with the guidance of the BCSLA Board of Directors and a professional webmaster. The database has the ability to: monitor CE credits, assist BCSLA Interns in tracking their work experience and progress through the LARE, update contact information and membership status, link firms and services offered, online event registration, and more. Volunteers are collaborating with the webmaster to update the websites to be "Mobile Friendly" as defined in the BCSLA Five-Year Strategic Plan.

#### **Digital Stamp**

Many BCSLA Registered Landscape Architects reported that an increasing number of public sector agencies required documents be sealed digitally. In 2018 the BCSLA Board of Directors approved the implementation of a digital seal option for BCSLA members. Modern legislation (the Electronic Transactions Act) is in place in BC that makes electronic documents as enforceable as printed documents, and allows for digital production and electronic delivery of landscape architectural instruments of service. After extensive evaluation of the Digital Signature market, BCSLA Board approved the selection of Notarius to provide the BCSLA Digital Seal to Members. Please note that use of a digital seal (and the associated costs) are totally voluntary; no other form or process of digital seal is permissible Rubber stamp or approved digital seal will be the only approved methods of sealing documents in BC. Many other professional associations including the AAPQ, AALA, AIBC, AIC-BC, BCIA, EGBC, MALA and more have moved to a digital seal option. You may also choose to continue to use your physical stamp and ink.

#### **Complaints**

In 2019 - 2020 we received several complaints regarding misuse of title. The BCSLA aggressively monitors the use of title in this Province and does inform these individuals of the conditions of the Architects (Landscape) Act. We request that individuals or firms who use the name in error cease and desist using the title and to revise all promotional material that imply the individual was a landscape architect or that a landscape architect was on staff. Thank you to Members for keeping the Society informed when they learn of misuse of title.

#### **Credentials Assessment Improvement Fund**

A grant was received in 2020 from the Province of BC to improve our membership application processes including Internationally Trained Workers. The grant monies will offset the costs for updating the multi-lingual licensure website, allow for secure online applications, develop secure portals for application review by the Credentials Committee and the Board of Examiners to expedite the application process and reduce barriers to licensure for Internationally Trained Workers. At press time a follow-up grant was submitted to continue work on this project.

#### In Memoriam

#### **Eric Clough**

Eric began practice in 1954 in California, one of the first Landscape Architects to recognize the need for drought tolerant species in xeric landscapes. He brought that sensibility north in the late 60's where he and his family built a community three miles from the closest power. Building a practice without power or a phone was but one of many challenges Eric overcame during his 65 years as a Landscape Architect. When he began receiving his old age pension and CPP he pledged to work at least 50% of his time pro bono. Two major community housing projects for seniors in the Slocan Valley are but a small part of that legacy.

#### **David Fushtey**

A true renaissance man, Dave was a landscape architect, sculptor and multi-talented lawyer. His first degree in landscape architecture led to his work on EXPO '86 but his fascination with the law and words led him to pursue a law degree at UBC and work in international commercial organizations and transactions. Dave successfully pursued his passion for stone sculpture but his commitment to words and the rule of law drew him back to create The Governance Counsel in 2002 and his career thereafter focussed on governance - the effective exercise of informed authority.

Dave worked tirelessly on behalf of the BCSLA. He was instrumental in leading workshops that resulted in our Bylaws and Standards of Professional Conduct and Practice and many Policies that are in place today. He provided excellent guidance on legal matters, governance, strategic oversight, discipline, compliance and more recently Bill 49: The Professional Governance Act. Dave always showed leadership, kindness and courage. He worked tirelessly in his pursuit of justice whether for politics or humanitarian causes including support for women and diversity of culture. Dave is dearly missed.

#### **Ismet Olcay**

1930 - 2019

1955 - 2019

Ismet T. Olcay passed away peacefully at the age of 95 in New Westminster in March 2019. He was a professional Landscape Architect, who had a stellar career, working in various levels of government in park planning and design including Coquitlam, Canadian National Parks, Provincial Parks in Ontario and BC. He was proud to have been on the Canadian contingent to IFLA congress numerous times and also helped organize a conference for IFLA in Victoria BC.

#### **Clive Lionel Justice**

Clive Justice, LMBCSLA #003, FCSLA, Landscape Architect, Planner, Author and Garden Historian, died in his sleep at his home in Vancouver. Clive used his WWII veteran's education allowance to study Landscape Architecture at the University of California, Berkeley, where he met and married Wanda Peckinpah.

Clive blazed a trail in his professional life in BC as one of the first registered landscape architects in the province, mentoring a number of enthusiastic interns and employees. Among the firm's notable projects were Park & Tilford Gardens and UBC Botanical Garden. Clive was a founding member of the Vancouver Rhododendron Society and active in protecting local parks and Vancouver's heritage trees. A volunteer with Canadian Executive Services Organization, he spent several years after retirement working with park planners in a number of developing countries. Clive was elected a Fellow of the Canadian Society of Landscape Architects and was an American Rhododendron Society Gold Medal recipient.

Ever up for a challenge, Clive entered a PhD program at SFU to study garden history, receiving his doctorate in 2002 at the age of 76. He was a prolific and creative builder and designer and a gifted communicator. He will be remembered for his insatiable appetite for knowledge, sartorial flair (Stetson, western suit and boots, then later, Scottish kilt and related kit), and irrepressible energy, but especially for his service to the community and indomitable force of personality.

#### **Keith Koroluk**

1954 - 2020

Keith Koroluk. MBCSLA #116, passed away suddenly from natural causes on November 24, 2020 at his home in Vancouver. He completed his undergraduate degree at the University of Saskatchewan in Saskatoon. Keith then relocated to Winnipeg where he took his professional training at the University of Manitoba earning a Master of Landscape Architecture. He received several academic awards including the Manitoba Association of Landscape Architects Award of Excellence in the study of Landscape Architecture. Keith was a proud member of the British Columbia Society of Landscape Architects and left an impressive legacy of beautiful award-winning projects that will be enjoyed for many years to come. He was a uniquely creative individual who took great pride in his work.

### **TREASURER'S REPORT**

Due to the COVID-19 Pandemic there was no 2020 BCSLA Annual General Meeting. This report covers 2019 and 2020. If you have any questions or comments, please contact Wai-Sue Louie, Treasurer and Tara Culham at the BCSLA office.

#### 2019 Revenue

The actual revenue line item was close to the 2019 budget forecast. BCSLA Membership numbers remained steady and dues revenue met the budget forecast. In 2019 the BCSLA hosted the CSLA Annual Conference in Vancouver from May 7-8, 2019. The revenue and expense line items were adjusted to address uncertainties related to the risks and rewards of cohosting the event. Upon reconciliation of Conference financials, the BCSLA portion of the revenue share was \$13,794.

As a founding Member of the BC Land Summit Society the BCSLA was one of the organizers of the 2019 BC Land Summit that was held from May 8-10 in Vancouver, BC. Each Member organization recovered \$15,000 in costs when the BC Land Summit financials were reconciled. BCSLA continues to earn a royalty of 12.5% on sales of the Canadian Landscape Standard.

#### 2019 Expense

Most of the 2019 budget line items were within their budget allocations. CSLA Professional dues and fees in the amount of \$65,383.00 were submitted on behalf of BC Members and Associates. The Counsel Public Relations costs slightly exceeded the forecast for government relations consultation services related to Bill 49-Professional Governance Act. These costs were offset as the clerical assistant line item and other employment expenses were under the forecast as clerical assistant staff were not hired until 2020. BCSLA granted several requests for funding support including the UBC Garden Design Lecture Series, regional events and advocacy.

BCSLA continued to support emerging professionals through scholarships, LARE Workshops, Student Outreach Programs, the UBC Book Program and more. Pauline Moskal was the recipient of the John Wesley Neill Scholarship in the amount of \$1,000 for the 2019 term. The Philip Tattersfield Essay Writing Scholarship for \$1,000 was awarded to Duncan Chambers. In 2019 the BCSLA Robillard Scholarship in the amount of \$1,000 was awarded to Mason Lam. Due to sound investment decisions by the LACF, who administers this scholarship, the award will increase to \$1,500 in 2021.

#### 2019 Audit

Mahmoud Virani Inc. conducted the annual audit. The audited 2019 year-end financial reports show a surplus in the amount of \$12,095. The audited financial statements were published to the BCSLA website upon the completion of the audit.

#### 2020 Revenue

In 2020 revenue was impacted by COVID-19. All inperson events were cancelled and there was no BCSLA Conference and Showcase in 2020. The conference will be held when Public Heath Orders are lifted, and it is safe to meet again. As a not-for-profit organization the BCSLA automatically qualified for a 10% reduction in source deductions (eg. CPP, EI and Income Tax) in the amount of \$3,153. The Source Deduction payment to the Canada Revenue Agency was adjusted to reflect CEWS. At the time this report was prepared, the annual audit process had just begun.

### **TREASURER'S REPORT (CONT.)**

Sitelines Magazine transitioned to a new format in 2020. BCSLA pays for Naylor Publications \$650 for each set of four additional pages for each issue of the magazine. Naylor Publications provides \$1,000 per issue to BCSLA as a share of the advertising, Naylor Publications also provides a revenue share of advertising in the amount of \$5,000 for the BCSLA Annual Membership and Firm Roster.

CSLA began offering complimentary copies of the Canadian Landscape Standard to CSLA and CNLA Members at no cost. This deeply impacted the royalty that BCSLA and BCLNA earn as the original owners of the document. A royalty of 12.5% of the sale price per copy will be paid to each the BCLNA and BCSLA. This royalty payment will end in 2025.

#### 2020 Expenses

In 2020 expenses were impacted by COVID-19. All in-person events were cancelled, and meetings pivoted to an online platform. As such there were no expenses such as meeting room rental, catering, travel and more. In 2020 CSLA professional dues and fees in the amount of \$79,276 were submitted on behalf of BC Members and Associates. The Counsel Public Relations contract was renewed in 2020. In 2021 it was agreed to retain Counsel Public Relations on an as-required basis. BCSLA continues to support emerging professionals through scholarships, LARE Workshops, Student Outreach Programs, the UBC Book Program and more. In 2020 the BCSLA Robillard Scholarship in the amount of \$1,000 was awarded to Vicky Cen. With thanks to LACF and wise investments the Robillard Fund was increased to \$1,500 in 2021. Jessica Udal was the recipient of the John Wesley Neill Scholarship in the amount of \$1,000 for the 2020 term. The Philip Tattersfield Essay Writing Scholarship for \$1000 was awarded to Beau Wuthrich.

#### 2020 Audit

At press time the 2020 audit was being finalized by Mahmoud Virani Inc. Upon review and approval by the BCSLA Board of Directors the results will be available on the BCSLA website.

#### **Special Levy Account**

At the April 27, 2019 AGM it was resolved by a Special Resolution of the Members that the BCSLA allocate a maximum of \$28,000 from the Special Levy fund for the period 2019 to 2021 in support of the Landscape Architecture Project V. The funds will be used at the discretion of the Board of Directors to conduct a review of Bill 49 and the issues related to: Architects (Landscape) Act, Bylaws and Standards of the Profession, labour mobility and governance. Funds may also be expended for contractors to provide legal and government relations advice as required

On March 31, 2021 there was \$7,711 in the Special Levy Account. There was \$20,491 in the Term Deposit that is linked to the account. At their April 2021 meeting the BCSLA Board of Directors passed a Motion to allocate \$10,000 from the Special Levy Term Deposit to the Special Levy Account and reinvest the balance and the interest to a 12 Month Non-Redeemable Term at the best interest available. Please see Special Resolution 2.

#### **Emergency Fund**

BCSLA continues to invest funds in the Emergency Fund on an annual basis. As of March 31, 2021 there was \$154,111 in the dedicated term deposit. The term deposit principal and interest was renewed in May 23, 2021 in a 12 Month Non-Redeemable Term at the best interest available. Note that \$40,000 of the Term Deposit was transferred into the general account. Please see

### **TREASURER'S REPORT (CONT.)**

Special Resolution #3 for complete details. Standard Accounting Practices recommend that approximately 30% of the budget be set aside for use in emergencies. This would cover the costs of relocating the office and contents due to fire, theft, etc. and other operational costs. The fund is not available to cover shortfalls.

#### **Building Fund**

At the 2000 AGM the membership approved the purchase of strata titled office. The Office Space Sub-Committee was tasked with making recommendations to the Board of Directors. Upon identifying a suitable property volunteers and staff met with the bank manager with the goal of determining what financing the BCSLA could acquire for an office purchase. A preliminary assessment indicated that the BCSLA was not able to proceed with the purchase of strata titled office. The 2011 Strategic Initiatives Survey indicated that less than 4% of the Members supported the purchase of strata titled office space. The current office lease expires on November 31, 2030. Over time the funds were invested in dedicated term deposits. Today the Building Fund is \$63,063 and will mature on August 11, 2022 maturity date. Please see Special Resolution #3 for a recommendation by the BCSLA Board of Directors.

#### **BCSLA Office Staff**

Tara Culham continued to serve as the BCSLA Executive Director. In January 2020, Devon Francis was hired as the BCSLA Member Services Coordinator. Since that time, in recognition of her work, Devon's salary was increased to match industry standards. In 2021, Devon was provided with extended medical benefits. Staff performance reviews are held throughout the year. The BCSLA Board of Directors is currently seeking a Regulatory Coordinator to assist the Registrar and support efforts of the Regulatory Review Task Force. Please see the President's Report for complete information.

#### Living Wage for Families

The living wage is a bare-bones calculation that looks at the amount that a family of four needs to earn to meet their expenses. The living wage includes costs like rent and groceries as well as items like extended health care and two weeks savings for each adult. It does not include debt repayment or savings for future. BCSLA adheres and goes above the guidelines to encourage continuity in staffing levels and match industry standards.

#### 2021 Budget

In accordance with our Bylaws, the BCSLA Board of Directors approved the budget that is included in the 2021 AGM package. The Board continues to take a cautious approach to the budget forecasting procedures, and this is reflected in the 2021 budget. The 2021 revenue and expenditure line items were reduced due to the uncertainty related to COVID-19 including hosting the 2021 BCSLA Conference and Showcase of Products and Services. The Board will proceed with initiatives, as defined by the updated Five-Year Strategic Plan. While the Vision, Mission and Values of the BCSLA continue to guide the Society. Please see the Strategic Plan Report. The 2021 budget shows a balanced budget of revenue and expenses.

At the November 18, 2020 Board of Directors meeting, the Bank of Canada had established the Consumer Price Index as 0.7% (see http://www.bank-banquecanada.ca/en/index.html). The Board approved a Motion to increase the BCSLA portion of the 2021 professional fees by 0.7%. CSLA Member fees remained at \$200. The CSLA Intern and Associate fees remained at \$20.

The 2021 Approved Budget is included with this report. The BCSLA Board of Directors will continue to be accountable with the funds provided by the Membership and other initiatives. Thanks to the decisions of previous Boards and the Membership, the BCSLA has the

financial capacity to continue with projects that will benefit the Society and the profession without undue financial strain. The Board welcomes new initiatives from the Membership that will continue this growth.

### **CSLA 2019 REPORT**

The CSLA is the national voice of the profession in Canada. In 2019 CSLA membership grew to over 2,800 landscape architects, intern and associate landscape architects, and landscape architecture students.

In 2019 CSLA engaged in a pilot project to raise the profile of the profession in Canada. Called L.A.W. (Land Air + Water) various outreach techniques were used including social media and face-to-face meetings with Members of Parliament and civil servants to expand the CSLA presence in Ottawa and raise awareness about what our profession does and what we can do for the country (Canadian Landscape Charter). Board members received a training in government relations in September, and we were sent home to reach out to our own MPs to talk about the profession in our home riding. The Election Toolkit prepared by CSLA in anticipation of the October 2019 Canadian election was useful, and pre-and post-election saw various CSLA committees undertaking advocacy actions including commenting on federal budget briefs, preparing a submission to the Standing Committee on Finance, and reviewing various policy documents.

IFLA declared a Climate and Biodiversity Emergency at the Oslo World Congress in 2019 and set up a Climate Change Working Group chaired by CSLA members Colleen Mercer Clarke and Hope Parnham to implement a 2019-2021 climate action plan. CSLA followed by making a similar declaration and setting up a Committee on Climate Change that includes BCSLA members Bev Windjack and Nicci Theroux. The CSLA web site has dedicated pages to climate change and has many resources and tools are available online to members.

Following cross-country research in 2018 by various component working groups from the Indigenous Issues Task Force, CSLA approved creation of a Reconciliation Advisory Committee chaired by Chris Grosset and approved an action plan for Reconciliation. The findings of the IITF helped us frame the theme for the 2019 joint CSLA/BCSLA Congress in Vancouver, which is discussed in more detail in the CE report. Again, the CSLA web site has dedicated pages to Indigenous issues and Reconciliation.

CSLA published four issues in Volume 21 of Landscapes/Paysages in 2019: 1) Lo! Carbon; 2) Awards of Excellence; 3) Reconciliation 3) Beauté.

In 2019 CSLA was accepted as an NGO member of the Canadian Committee of the International Union for the Conservation of Nature (CC-IUCN), opening pathways for collaborations with other conservation-minded government and non-government agencies in Canada and beyond. I was appointed to be the CSLA member representative and attended my first meeting in Ottawa in January 2020.

I invite all members to visit the CSLA website https:// www.csla-aapc.ca/csla-aapc which has been organized around the various committees and is constantly being updated with information and tools to help us in our work.

### CSLA 2020 REPORT

The CSLA Board prepared a new Strategic Plan for 2021-2023 that was approved at the 2020 AGM. It builds on results from a member survey and evolving into specific seven mission areas including some ongoing committees, and the creation of three new\* missions to address new areas on concern to the profession:

- Urban Canopy Working Group
- Climate Change Committee
- Reconciliation Advisory Committee
- \* Diversity & Equity in the Profession Task Force
- \* Cultural + Historic Landscapes Committee
- \* Human Health & Well-Being Committee

In June 2020 the Black Lives Matter movement intersected with our profession. Directly affected and concerned members formed the Common Space Coalition and called on the CSLA and components to respond to the need for greater equity and diversity in the profession. CSLA condemns discrimination and all forms of racism that permeate our society. Prior to the AGM meetings were convened for discussions between provincial, regional, and territorial component associations and the Landscape Architecture Canada Foundation. The Strategic Plan was amended to add Diversity and Equity as a priority mission area, and this was approved on June 18. A formal statement was issued in August 2020, and the Diversity & Equity in the Profession Task Force was established in November and tasked with hiring a consultant to guide the development of a national and provincial action plan for the profession.

Going forward, changes have been made to composition of the Awards of Excellence jury, ensuring that the jury is balanced in terms of diversity, age, gender, and geographic representation.

The CSLA and provincial, territorial, and regional component associations collaborated on a diversity survey in November 2020, results will be available in

2021. This survey will be circulated to members every year to update the data on the profession.

Web pages for each of the mission areas had been set up, and in the case of new missions, chairs were appointed and calls for interested members were extended through eNews and the website. We are grateful for the response from members that have volunteered their time to the committees, working groups, and task forces. Check out the webpages for more information about mission statements and work plans. https://www.csla-aapc.ca/mission-areas/missionareas

I am chairing the Human Health + Well-being Committee and am also serving as the Board Champion on the Landscape Architecture Accreditation Council (LAAC).

Since March 2020 all CSLA Board and committee work moved to meeting virtually using Zoom and other platforms, which has proven to be a positive experience that replaces the dial-in teleconference system used for many years. When it became clear that the 2020 CSLA congress and AGM scheduled for Calgary would not take place due to the pandemic, CSLA shifted its AGM online and held a very efficient and well-attended virtual video AGM on June 18th. A decision was also made in 2020 to hold the 2021 Congress virtually from May 27-29 rather than meeting face-to-face in Ottawa.

Landscapes/Paysages: four issues were published in Volume 22, 2020: (1) Spirit; (2) Awards of Excellence; (3) Collaboration; (4) Trees. All are available electronically.

#### Master of Landscape Architecture Program

In the 2019 to 2020 academic year we admitted 21 new students into the MLA Program from an applicant pool of about 95. David joined the MLA Program in 2016 as an Instructor and has been instrumental in reworking the curriculum of a number of core courses, including the Introduction Design Studio, Grading & Drainage, and Site Planning & Analysis. We wish David best of luck in his new position as Principal at Unknown Studio in Baltimore, MD.

#### **Adjunct Faculty**

Many other BCSLA members contribute their time and expertise as thesis reviewers, guest critics and lecturers. All of these contributions make the program a richer experience for our students.

#### Philip Tattersfield Essay Competition

The BCSLA and the Landscape Architecture Program jointly run the Tattersfield Essay Competition each January. The winner of this competition receives a \$1000 scholarship funded by the BCSLA and has the winning article featured in the student- edited issue of Sitelines. The essay "Stanley Park: Crystallized Wilderness" by Beau Wuthrich was chosen as the winner of the 2019/20 edition of the Philip Tattersfield Scholarship, his essay can be found here: https:// www.bcsla.org/sites/default/files/Tattersfield-Beau%20 Wuthrich.pdf

#### Landscape Architecture Student Association

The Landscape Architecture Student Association (LASA) continues its key roles of: representing the landscape architecture students in SALA, developing student events, and practicing leadership and mentorship with the students. LASA continued past years' work toward its goal of becoming more integrated with the architecture and environmental design students by: increasing activity on the School's Student Executive Committee, occasionally attending each other's student body meetings, aligning each other's goals, and working together through various initiatives, particularly when it

comes to wellness and curriculum. In 2019 - 2020 LASA has continued and revamped past traditional events and added smaller events and initiatives that enrich the day to day experiences for the students.

#### **Events/ Initiatives:**

- 1. Fundraiser: LASA continued Plant Sales as a fundraising and wellness initiative. We completed one plant sale of small tropical plants at the Corn Roast. These initiatives supported our wellness goals by greening our studio space and therefore making it a more pleasant space to work.
- 2. Wellness Initiatives: Programming focused on providing opportunities for students to take physical and mental health breaks as well as healthy eating.
  - a. Physical Activity: Monthly lunchtime yoga and walks around campus gardens were organized
  - b. Healthy Eating: Using money from the LASA budget, fresh fruit has been purchased for students, particularly first years, every month.
  - c. Wellness Survey: A wellness survey was conducted and expanded to include Architecture students to gain insight into the mental and physical health of the LASA student body. Results were compiled and shared with faculty. The information from the survey is being discussed in order to understand what LASA can do to better contribute to the mental and physical health of students in the program.
  - A result of the survey included recommendations to form a SALA-wide wellness committee. Sahar Khelifa (LASA Wellness rep) pursued this initiative with assistance from Architecture's wellness rep.

- 5. Mentorship Program: LASA matched up each 1st year students with a 2nd or 3rd year student mentor to help with any questions or concerns they had, particularly at the start of the academic year.
- 6. MLA Fall welcome event: The Corn Roast. The Corn Roast continued the tradition of Harvest Times by bringing the students together for a harvest themed event. This year, this celebration was focused specifically on MLA students, so that new students could better integrate with their upper years, who had their studios in a different building than the first years. LASA catered the event with freshly harvested corn, and other harvest cuisine. The Landscape Annex was decorated with all manner of corn-related paraphernalia, including a giant corncob mascot that LASA named "Cornelia." The event was a huge success, and inaugurated LASA's new Garry-Oake machine.
- Garry-Oake Nights. In an effort to introduce more regular social events for MLA students, a casual Garry-Oake night was hosted monthly after studio. LASA encouraged students to destress by singing their worries away into a newly acquired karaoke machine.
- 8. Annual Harvest Times: The annual Harvest Times, this year rebranded as "Garden Times," took place in November 2019. This event continued the tradition of earlier harvest times by bringing all SALA students together. Students were encouraged to green up their studio space with our plant sale, and our new "Garry-Oake" machine led the entertainment for the night. The event was a huge success, which saw a large attendance from the Environmental Design students, Architecture Students and Landscape Architecture students.

- 9. SALA GALA: The annual SALA Gala took place at The Emerald Room on March 7, 2020. It was very well attended, and themed "Murder Mystery." Participants were invited to dress in monochromatic colour schemes. For many, this was the last social event before the realities of the COVID 19 pandemic reached Vancouver.
- 10. Landscape Lunchtime Talks: LASA has continued the lunch lecture series with four lectures held this year. Our Vice President Internal, Julia Higson, curated four speakers with diverse experience in the landscape and planning disciplines. Our presenters this year were:

Sarah Thomas transitioned into the role of BCSLA Intern and Associate Rep in October of 2019 along with Sub-Committee members Aaron Li and Arlene Gillman. Our sincere thanks to the previous Intern & Associate Rep, Emily Hamilton, as well as Executive Director, Tara Culham, for welcoming our new Sub-Committee Members to the team. Emily provided us with a general overview of the role of the Sub-Committee and the upcoming tasks our team might have the opportunity to be involved with. The BCSLA Board and office also generously offered advice on navigating the registration process and our volunteer endeavours.

### Initiatives for the 2019/2020 and 2020/2021

#### years:

- Meeting and networking with other Interns.
- Attending and promoting LARE Study Workshops / Webinars.
- Organizing a LARE Study Group
- Reviewing ways to assist Interns & Associates locate work and find mentors, especially for those who have recently moved to BC and may be unfamiliar with the membership and / or not have many connections. Ideally through meet and greets and other networking events.
- Providing opportunities for Interns & Associates to achieve the required CE credits.
- Working together as a team of three (3) to accomplish tasks set forth. It has been a great help to have other interns to work through problems and discuss topics.

 Responding to the changing needs and requirements of interns during the pandemic. Have they had any difficulty fulfilling their experience hours (for example, if working from home are they able to have successful virtual meetings with their mentors, reduced site visits due to pandemic restrictions, etc.)

#### **BCSLA Regional Meeting & Idea Exchange**

Sarah Thomas attended the BCSLA Regional Meeting & Idea Exchange in Victoria in October 2019 and was introduced to the Board of Directors and Island Members and Associates who attended the event. Sarah thoroughly enjoyed attending the three (3) seminars that were offered, the tour of the Empress Hotel and its grounds along with the casual networking events. It was also a great introduction to how the BCSLA Board runs their meetings and the important work they take on for the membership.

#### BCSLA / UBC Library Book Donation Program

Each year the BCSLA contributes \$500 to the program which is matched by the UBC Library. The books will assist emerging professionals who are on the road to licensure as landscape architects. The BCSLA will be recognized in the online book catalogue and a bookplate as the book donor. The Sub-Committee worked with UBC Music, Arts and Architecture Librarian, Paula Farrar, to develop a suggested book purchase list for the UBC Library. In 2019/2020 under the guidance of Tara Culham and UBC SALA Representative, Susan Herrington, we selected 17 hardcopy titles to add to the Landscape Architecture Collection. In 2020/2021 under the guidance of Tara Culham and UBC SALA Representative, Kees Lokman, we selected a total of 12 titles that were a mixture of e-books and hardcopy books.

The pandemic has created a certain urgency in the need to look at strategies to offer students access to resource materials when they cannot be on campus to access the library. Not all books are available via e-book (online) and the pricing for e-books can vary drastically. Quite often they are more expensive than the hardcopy versions and there are further complications such as the number of licensed downloads they are allowed for each e-book. We think an inclusion of some e-books for the library book purchase list each year would beneficial to the students.

The Intern & Associate Sub-Committee discussed starting a book club as a possible CE credit activity for Members and Associates. This task was put aside but may be looked at again in the coming months, depending on interest. Anyone who interested in receiving the list of books chosen in 2019 or 2020, please feel free to get in touch with the Sub-Committee, as we would be more than enthusiastic to share the great reads that we settled on in our final list of titles.

#### **BCSLA Philip Tattersfield Essay Competition**

The BCSLA and the UBC SALA Architecture Program jointly run the Philip Tattersfield Essay Competition. The winner of the competition receives a \$1,000 scholarship funded by the BCSLA and the student work is promoted in the BCSLA Friday File.

In 2019/2020, Sarah Thomas assisted UBC SALA Rep, Susan Herrington, with running the essay competition. There were two (2) student entries. The jury members were Susan Herrington (UBC SALA Rep), Somaye Hooshmand (BCSLA Director), David Thompson (MBCSLA and CE Committee Member), Fionn Byrne (UBC SALA Assistant Professor) and Sarah Thomas (BCSLA Intern & Associate Rep). Beau Wuthrich was announced the winner and Christen Oakes was given

an honorable mention. Congratulations! In 2020/2021 the winner is yet to be announced Four (4) entries were submitted by the deadline. The jury members were Byron Douglas (BC Interior Chapter Chair), Patrick Mooney (UBC SALA Associate Professor), Erik Mustonen (BCSLA President-Elect & Professional Relations Committee Chair). Ron Rule (MBCSLA and FCSLA) and Sarah Thomas (BCSLA Intern & Associate Rep). This year, under the advisement of Kees Lokman (UBC SALA Rep), we changed the topic to only be a suggestion to use the UBC or BC archives, rather than a mandatory requirement, to document a local (B.C.) landscape over time and discuss how the design of that landscape took into account change. Due to Covid-19, many UBC students were not in BC and were unable to use or access these services. Both the UBC SALA and BCSLA offices sent out email blasts, Friday File postings and used their social media accounts to bring attention to the competition. # Landscape Architecture Registration Exams (LARE)

The main focus of Interns is to gain their experience hours and write their exams. In addition to the information found of the BCSLA and CLARB websites, we have found the LARE Workshops hosted by the BCSLA / AALA / OALA on the second Saturday of the month (when available) to be the most beneficial source for learning about the exam format and provide opportunities to form study groups and become familiar with exam content.

In 2019/2020 our Sub-Committee Members attended several LARE Workshops / Study Prep Webinars, learning great tips and tricks from the guest hosts. The information we learned in these workshops was later shared with other BCSLA Interns who contacted the Sub-Committee looking for recommendations on where to find resource material and how to get started studying for the exams. In 2020/2021 we continued attending the LARE Prep Webinars hosted by the BCSLA / AALA / OALA. In October 2020, Tamara Bonnemaison (MBCSLA) volunteered to put together an engaging presentation which was co-hosted by Todd Reade (AALA Executive Director), Tara Culham (BCSLA Executive Director) and Sarah Thomas (BCSLA Intern & Associate Rep). It was an honour to introduce Tamara to the online audience and to hear the approach she used to get ready for the Section 1 exam. The BCSLA office continues to encourage attendance to these workshops and is also seeking volunteers who are willing to step up and share some of their study tips. Anyone interested in preparing a workshop, please reach out to the BCSLA office.

In 2020/2021, our Sub-Committee Members along with one other BCSLA Intern, Fayez Rawas, started a LARE study group. Meeting on several occasions to discuss study material and questions for each chapter. Our team has put calls out in the Friday File for other Interns who may be interested in joining, however, there has been little to no response. We endeavor to work on providing more opportunities to establish relationships with other Interns on the road to licensure.

2020 proved to be a challenging year with the pandemic. AALA, BCSLA and OALA participated in a CLARB Pilot Program which provided Interns with the opportunity to write Section 1 and 2 of the LARE's with remote proctoring. A positive move that may provide options for our young professionals who are not based in the Lower Mainland or Victoria even after

the pandemic ends. The Pilot Program was a success. Section 1 and 2 of the LARE are now available to all LARE candidates. CLARB is testing options that will provide a platform to write all LARE in a remote setting. Additional information can be found under the Registrar's report. Also, please see the Registrar's Report for LARE pass rates.

#### **Intern Social Gatherings**

In the early months of 2020, our Sub-Committee was making plans to organize a spring / summer social gathering for Interns. We had the idea of a walking tour involving a discussion of public landscapes along the sea wall with a pub night or picnic at the end. This event was deferred due to public health restrictions that were put into place with the ongoing pandemic.

We also promoted an online gathering via Zoom, however, the response was poor and it was only attended by Sub-Committee Members. We recently discussed attempting to hold another online social night to give Interns and Associates the opportunity to network and get to know one another. In our involvement of working together on the Sub-Committee, we have found it most helpful to make connections with other interns as we each have a different background of experiences and education to draw upon, which can be beneficial when preparing for the exams. We remain optimistic that later this year (2021) an outdoor meet-up may be possible, however, this will be dependent on the guidelines and recommendations set forth by the Public Health Minister.

# Outdoor Learning in BC Schools Working Group

The unexpected challenges of Covid-19 have made the world rethink how we use our surroundings and about

the positive impact the natural environment can have in our daily lives. Our Sub-committee came across several articles outlining various BC Public Schools that were attempting to respond to the pandemic by finding ways to increase the amount of time children spent outside as well as the use of temporary outdoor classrooms. We were also interested in the USA based National Covid-19 Outdoor Learning Initiative, a program that is working to facilitate outdoor learning in schools across the United States. We began compiling a resource document with various articles and links to information on outdoor learning. We presented our research to the Board and a call was put out to the general membership for volunteers who wanted to participate in exploring the feasibility of expanding outdoor learning in BC Public Schools. We had several Registered Members and Interns show interest in the volunteer initiative and we met on a monthly basis to review ideas for the types of projects (e.g. research writing) that we could take on and what some of the potential outcomes of our work could be. Currently the group is comprised of four (4) Interns, Arlene Gillman, Aaron Ii, Fayez Rawas and Sarah Thomas, two (2) Registered Landscape Architects, Donna Rodman (BCSLA Director) and Josh Bernsen (MBCSLA), as well as an inspirational educator, Victor Elderton (non-BCSLA Member), who has worked closely with Donna on a project in the past. Donna graciously offered to assume the role of mentoring our working group. As it became clearer that the Interns involved in the project needed to define the type of work they could take on and participate in, we worked with Donna Rodman (BCSLA Director) and Al Neufeld (Registrar and Credentials Committee Chair) to define the limits of our work to a research-based writing project that could potentially be published in Sitelines or a similar

magazine. We are currently working on establishing our research questions and investigating potential BC Public Schools that could be used as case studies for how they responded to the pandemic in the last year. We are also exploring options to see if our work will qualify for an LACF grant in the future.

We look forward to sharing our research with the general membership when complete and hope to increase public awareness of the key role Landscape Architect's take on in enhancing people's experiences where they live, work and play. We also wish that our work may broaden views of what a typical school could look like. The subject also has the potential to tie into environmental themes as well as meaningful reconciliation with Indigenous communities in BC, there is much we can learn from Indigenous perspectives on the environment and their sense of connection, community and place. We continue to promote and recruit Interns and Members to join our working group and participate in this valuable research project.

The subject of liability for mentors and interns was brought up through the discussions of this volunteer group as a way for the interns to understand the limits of the scope of work they should be taking on at this point in the careers. This topic was already under review by several board members and committees, so timing was appropriate. The Intern & Associate Sub-Committee was asked to provide feedback and comments on a report that was being prepared by BCSLA Director, Donna Rodman, and Registrar, Al Neufeld. We thank the Board for including us in the discussions on this topic. The ongoing discussions and investigation will ensure all members understand the limits of their liability. See the Registrar's report for more information.

#### BCSLA 2019 & 2020 AGM

The upcoming AGM will be held July 10,2021 using a virtual platform. This will be the first opportunity for all

three (3) Sub-Committee Members to attend. We are looking forward to the program.

#### Moving Forward for 2021/2022

- We will continue to promote activities that are relevant to the professional aspirations of the Interns & Associates.
- The Intern & Associate Sub-Committee will renew planning for LARE Workshops with the assistance of Tara Culham, as well as the respective representatives from the AALA, MALA, and OALA.
- We will continue our work on the research writing project the Outdoor Learning In BC Schools Working Group has undertaken.
- We will pursue opportunities to connect with Interns & Associates and support them in their goals of becoming Registered Members.
- We will research ideas for promoting historic BC Members of our profession, for e.g. Philip Tattersfield with the new generation of Interns & Associates. We will review this work with other Committees to see how we might best accomplish this goal.

Aaron, Arlene and Sarah have created a strong cohesive team and have thoroughly enjoyed the opportunity of working together and creating a support network through these unusual times.

#### **2019 Event Highlights**

CSLA/BCSLA Congress 2019: Your CE Committee cohosted the 2019 CSLA/BCSLA Annual Congress held at the Vancouver Westin Bayshore May 7-8. Planning the Congress around the theme of Acknowledgement, Awareness, and Engagement – Landscape Architecture and Reconciliation was an eight-month effort and we were grateful to Grant Fahlgren, BCSLA Intern, for joining us from the CSLA Indigenous Issues Task Force to help us. We thank again Audrey Seigl of the xwmə0kwəyam (Musqueam) First Nation for her opening welcome, and Lorelei Williams for raising awareness about the National Missing and Murdered Women and Girls Inquiry and Butterflies in Spirit, an Indigenous women's group that uses dance to raise awareness about MMIWG. We are grateful to the three Indigenous keynote speakers that helped frame, focus, and broaden our awareness of the ongoing challenges and threats to Indigenous people in this country: Grand Chief Stewart Phillip, Julian Napoleon, and Wanda Dalla Costa. Within the conference program, all speakers co-presented with Indigenous elders, knowledge keepers, and/or designers that travelled from their territories to tell their stories alongside their CSLA project collaborators. Walking, cycling, and paddling tours were organized to connect congress participants to the unceded land

beneath the city, and understand how land use layers have been overlaid since European contact. The very hard work of the committee members resulted in a very successful conference in perfect Vancouver spring weather. The committee members were Kathy Dunster (Chair), Grant Fahlgren, Nancy Paul, Dave Thompson, Nastaran Moradinejad, Bahareh Nassiri, Dorsai Sharif, Cindy Hsu Becker, Patricia Gooch, Emily Hamilton, and José Gonzales who cheerfully worked for their fine skills in strategic planning and logistics – both visible and invisible alongside staff support from Michelle Legault (CSLA ED) and Tara Culham (BCSLA ED)

BC Land Summit: As a partner in the BC Land Summit Society, BCSLA participated in the successful 2019 BC Land Summit Collaborations + Connections, held May 8-10 at the Vancouver Westin Bayshore with keynote speakers Sheila Watt-Cloutier and Edward Glaeser, and featured dinner presenter, Mark Critch. Your CE Committee grew in 2020 and I would like to acknowledge and thank those long-time members that continue to serve and welcome the new members to the committee. It is a delight to chair CE meetings with Nancy Paul, David Thompson, Nastaran Moradinejad, Dorsai Sharif, José Gonzales, Cindy Hsu Becker, Kelly Kang, Qing Li, Bahareh Nassiri, and Pearl Yip.

#### CE Policy Changes (2020-2021-2022 Cycle)

On May 18, 2021 the BCSLA Board approved a CE Policy change recommended by the CE Committee. The BCSLA CE Policy will now shift from a 3-year 30 credit reporting cycle to a 1-year 10-credit reporting cycle. Members will be required to file their annual CE credits (10) prior to, or with payment of their annual dues.

- In consideration of the stress of the COVID-19 global pandemic and difficulty many members have had in reporting CE for 2020, the 2020 CE requirements will be waived. Many thanks to those that filed by December 31, 2020.
- In 2021, all members and associates must attend a mandatory PGA webinar in May or June 2021, worth 10 credits. Members must log in to www,bcsla.org and report their attendance (details provided in the Friday File.
- 2022 will be the first regular 1-year reporting year.

#### **Continuing Education (CE) Credits**

Beginning in 2020 BCSLA Members may no longer claim credit for employment. All BCSLA Registered Landscape Architects, Landscape Architects, Inactive Landscape Architects, and BCSLA Interns must submit CE credits to the BCSLA office using the online CE Form by logging in at www.bcsla.org Please contact the office if you need help. Continuing education is a mandatory requirement for membership in the BCSLA and members that fail to file CE before the end of this cycle will be subject to penalties, fines, and potential removal from the register of members in good standing.

The pandemic has created different opportunities for gaining CE credits, and in the next few months the CE Committee will be reviewing credit categories and making necessary changes to ensure that the many (151) ways to obtain CE credits are clearly articulated. We welcome suggestions and contributions from all members.

#### Pivot to on-line CE: Webinar Wednesdays

By April 2020 it became clear that life would not get back to normal in the immediate future and the conference and all contemplated CE events were postponed and pushed towards late 2020.

In the meanwhile we began gleaning free online learning events on all topics related to the breadth areas of our profession, and with the help of Devon Francis, BCSLA Member Services Coordinator started a Webinar Wednesday email to members that rounds up our weekly findings of CE opportunities available online via various platforms. **Buildex 2020:** Many BCSLA members enthusiastically attended a day-long symposium hosted by ABT + Permavoid at the Hotel Vancouver on October 17, 2019 (topics covered Global and Local Water Challenges, Water Balance Modeling, Storm Water First Irrigation, Storm Water Structural Subbases, Connected Blue-Green Roofs, and Urban Tree Solutions). BCSLA CE was given the opportunity by Buildex to team with ABT, Permavoid and Basalite and hosted a free wellattended educational session at Buildex 2020 (Feb 13) on Resilient Landscapes and Stormwater Management. We are working with BUILDEX on an educational event that will occur during BUILDEX 2021 scheduled for the Vancouver Convention Centre in September, or if public health orders change, will be pushed to February 2022.

#### 2020 and 2021 Conferences

In Fall 2019, your CE Committee began planning for the 2020 June 11-13 Conference by selecting the theme "Back to the Garden" in recognition of the half century anniversary of Joni Mitchell's iconic song "Woodstock" which touched on the utopian ideal of getting back to the original garden in an intensely dystopian time of unwanted war, wacky American politics, and generational differences about life, destiny, and the universe. After Board approval in November 2019 the Call for Papers and Presentations went out and we received a richness of proposals from across Canada by the January 31 deadline. The committee met at the Pinnacle Hotel Harbourfront to finalize floor plans on January 16, 2020. Planning continued apace with presenter acceptances, tour topics, and the program was starting to come together at our last face-to-face meeting on March 5. On March 16, 2020 everything ground to a full halt as the WHO declared a global pandemic and we moved to lockdown. With

a conference ready to go, your CE committee took a much-needed break and waited for the re-opening of large-crowd events which never happened. June 11-13, 2020 came and went, and we still have a conference ready to go whenever we get the go-ahead.

#### **CE Events Planned and Currently on Hold**

Construction Law and Landscape Architecture workshop with lawyers Catherine Coakley and Stephanie Streat, specialists in construction and commercial litigation with Brooks Tomchenko Morrison. We look are looking forward to this session, either in late 2021 or 2022.

#### Looking ahead to 2022

The Registrar of Companies extended the date by which a society must hold its annual general meeting under section 71(3) of the Societies Act. The Board has decided to hold both the 2019 and 2020 AGMs virtually and concurrently on July 10, 2021 to meet statutory requirements, freeing up the conference to occur faceto-face when public health orders allow.

The CE Committee meets regularly via Zoom to discuss policy and potential events. We have been working with the RRTF to deliver the PGA mandatory CE events. We are monitoring public health orders closely and due to the uncertainty of the pandemic, our current preference is to look ahead to 2022 when we may be able to have the conference originally planned for 2020.

The Public & Professional Relations (P&PR) Committee meets monthly and was active in 2019 and 2020, on a variety of new and ongoing initiatives. P&PR benefitted from the addition of active, talented and energetic new members who stepped forward to join the committee. Thank you to those who have donated their time for the continuing development of the work of the committee.

The following is a summary of the some of the more significant accomplishments in the past two years:

#### **Sitelines Magazine**

As a result of a survey conducted by a task force exploring potential new directions for the BCSLA's flagship publication:

 The Sitelines Editorial Advisory Board (SEAB) was established as an energetic volunteer group to guide the creation of a re-imagined, more substantial professional publication with two full-size, full-colour issues per year rather than six half-size, black and white.

- SEAB solicited editorial content in the form of articles and graphics and worked in collaboration with Naylor Association Solutions to assemble, edit and publish the first three issues, Spring and Fall 2020 and Spring 2021 issue.
- Sitelines is circulated to a mailing list of 1,700 that includes BCSLA Members, allied professions, developers and all three levels of government. The updated mailing list is provided by the BCSLA.
- Sitelines is supported partly by advertisers and partly by funding provided by BCSLA. The contract with Naylor as publisher is in effect until 2022.
- The new Sitelines has become a valuable and effective means for showcasing the research, ideas and projects of landscape architects as well as others outside the profession. It has been recognized with a Gold Award in the Association Publishing category in the international MarCom marketing and communications Awards competition.
- The Sitelines Editorial Advisory Board includes Miriam Plishka, Lauren Cherzekoff, Divine Ndemeye, Jergus Oprsal, Jack Tupper, Don Vaughan, Celia Winters, Belinda Chan, Sophie MacNeil, Teena Aujla, and Erik Mustonen. Thank you to Thomas Llewellin who was on the original Board until 2020.

#### **BCSLA Annual Membership and Firm Roster**

The Sitelines Annual Membership and Firm Roster was renamed "BCSLA Annual Membership and Firm Roster" in 2020, to clarify its purpose and avoid confusion with Sitelines magazine. Naylor Publications organizes, plans, prints, and produces the Roster in exchange for the advertising revenue. BCSLA was provided with a \$3,000 signing bonus when the current five-year agreement was signed in 2019. The BCSLA earns an annual royalty of \$5,000 plus a bonus for other advertisements. The BCSLA provides Naylor publications with a mailing list of 1,900 that includes BCSLA Members, Associates and Affiliates, allied organizations, developers, all three levels of government and more. The P&PR Committee volunteers selected an image for the cover of its 2021 issue that features a Vancouver Island Project. In 2019 the cover featured a project from the Sea to Sky Corridor, the 2020 edition featured a project from Northern BC. Thank you to David Rose for his hard work on this initiative for so many years!

Naylor continues to publish the Roster as well as *Sitelines* magazine. It has proven to be an effective tool to connect suppliers and clients with Members and Associates BCSLA Landscape Architects.

#### **BCSLA Websites**

The previous two websites were consolidated with sitelines.org being absorbed into bcsla.org, which was upgraded with the assistance of Luna Design:

- The platform was updated to a new Drupal interface that allows images to be easily replaced.
- Navigation of the website is now easier and more intuitive.

- The Web Atlas of BCSLA Members projects, now has a more user-friendly Google Map-based location function for the projects.
- There is now a quarterly call for new Feature Project submissions for the Web Atlas. The themes so far have been as follows:
  - Summer 2020: Park Planning
  - Fall 2020: Collaborations with Architects, Engineers, and other Professionals.
  - Winter 2020/2021: Commemoration: Memorials, Cemeteries and Cenotaphs
- The Climate page featuring climate change issues, was added to the website (linked to the homepage) and launched on July 30, 2020.

#### **Diversity, Equity and Inclusion**

Members of the P&PR are strongly committed to issues of Diversity, Equity and Inclusion. This was relayed to the Board, which being equally engaged, voted to create a DEI Task Force that after establishing its strategic direction with the Board, will become a subcommittee under P&PR.

#### **Graphic Standards**

Graphic Standards developed by Brett Hitchins, BCSLA Associate, to provide a consistent graphic image for BCSLA, have been applied as templates to guide the creation of attractive fliers and programs – both online and printed, for regional meetings, the annual conference, AGM and other events.

#### **P&PR Binder**

The committee has had an on-boarding information binder for several years, to guide new members and chairs, in the functioning of the P&PR including responsibilities, typical activities and timelines. This binder is periodically updated.

### Union of BC Municipalities Annual

#### Conference

in 2019, as it has previously, P&PR operated a BCSLA booth at the trade show that was part of the UBCM Conference. There was no booth in 2020 due to the pandemic, but the P&PR Binder has been updated with information on the logistics of setting up and running the booth to aid future committee members.

#### **Construction Site Signs**

The BCSLA construction site signs were established in 2001. More than 50 large and small signes were ordered by BCSLA Members. The current construction site signs were developed by PPR volunteers in 2017. The sales of the BCSLA construction site signs have been slow.

#### **BCSLA Media Kit**

The majority of BCSLA revenue is generated by member dues and the Showcase of Products and Services at the annual conference. The BCSLA reviewed methods to diversify revenue sources and the BCSLA Media Kit was drafted and launched with a view to earning revenue by career opportunity advertising for non-Members, webinar and event support, logo placement and advertising in the BCSLA Friday File and more. As the scheduling of events is uncertain at this time due to COVID, the BCSLA cannot accept any booking for sponsorships for in-person BCSLA events at this time. When authorities have deemed it safe to gather again, staff will contact our generous sponsors.

#### Focus for 2021 / 2022:

- Assisting with webinars on the Professional Governance Act for BCSLA Members led by the BCSLA Regulatory Review Task Force (RRTF.)
- Strengthening the relationship between the BCSLA and the School of Architecture and Landscape Architecture SALA at UBC.
- Work with the Diversity, Equity and Inclusion Task Force once its direction has been established with the Board and set out in the updated BCSLA Strategic Plan.

With the help of Andrew Wasson at Luna Design, the subcommittee established a well-rounded and easily accessible Climate page on the BCSLA web site (https://www. bcsla.org/initiatives/climate-change-awareness). The page includes the 'Professional Leadership in a Changing Climate: Joint Statement' which the BCSLA adopted alongside the Association of BC Forest Professionals, The College of Applied Biology, the Association of Professional Biology, and the Planning Institute of BC, as well as six climate inspired 'boxes' that are filled with information on climate change, adaptation, research, green infrastructure, sustainable materials, tools/resources, and current educational opportunities. There are over 900 entries so far! The site is curated - new information is regularly added, and as posted information becomes obsolete it is removed. The BCSLA has been very active in the Adaptation Learning Network (ALN) and is represented on the Advisory Committee by Kathy Dunster, Bev Windjack, Jaqueline Lowe and Tara Culham. #### **Credentials Committee**

#### **Application Reviews**

Application deadlines are January 31 and June 30 of each year. All applications are reviewed by the BCSLA Credentials Committee who makes their recommendations to the BCSLA Board of Directors who have the final approval. In 2019 the BCSLA welcomed 31 new Registered Landscape Architects. In 2020 the BCSLA welcomed 19 new Registered Landscape Architects and 2 Landscape Architects. Several candidates were invited to appear before the Board of Examiners as reciprocity or senior practitioner candidates. In addition over this two year period, 68 BCSLA Interns and Associates, and 10 Students, were added to the Roster. We are proud to have individuals with such a high level of knowledge and skills within our ranks, and look forward to working together to promote a high standard of practice in BC, across Canada, and around the world.

#### Mentor Program Task Force

The Credentials Committee has established a task force that includes Daniel Roehr and Mark Vaughan. They are reviewing the BCSLA Intern and Mentor program to update communications regarding the responsibilities of mentoring and provide a training opportunity for mentors.

#### **BCSLA Associate Policy Update**

The Board of Directors approved a recommendation by the Credentials Committee to revise the BCSLA Associate Policy to clarify the requirements to be an Intern Associate versus a Pre-intern Associate. A Preintern Associate is now defined as: An Associate who is in the process of meeting all the requirements needed to apply as an Intern of the BCSLA:

- i. has been employed for less than six (6) years in the field of Landscape Architecture; or
- ii. has a degree in an allied discipline; or
- iii. work experience in a related field; or
- iv. has an equivalent combination of degree and employment in an allied discipline.

Upon acceptance the applicant is entitled to use the designation "BCSLA Pre-intern".

#### **BCSLA Intern Work Experience Forms**

The BCSLA Credentials Committee through the leadership and initiative of Somaye Hooshmand reviewed the BCSLA Intern Work Experience Forms and online input portal to update categories of work experience to be more inline with the latest CLARB Task Analysis. The Board of Directors approved the changes to the Work Experience Forms. A group of Interns have volunteered to test the new forms and suggest any further improvements. These changes will be incorporated in the updated online application portal as part of the Credentials Assessment Improvement Fund project funded in part by a grant from the Province of BC. One of the goals of this project is to facilitate the review of membership applications online by both the Board of Examiners and the Credentials Committee to expedite the application process and reduce barriers for Internationally Trained Workers.

#### **Change of Status Form**

While the Credentials Committee typically meets twice a year, with the additional project specific work the committee has met more frequently to complete specific tasks. We are fortunate to count Illarion Gallant, Somaye Hooshmand, Al Neufeld, Daniel Roehr, Dimitri Samaridis and Mark Vaughan as volunteers on the Credentials Committee. They bring a wealth of information and experience to the Committee. Their time and energy are key to the success of the Society. We want to also acknowledge the contributions of long-time member Damon Oriente who has stepped down from volunteering on this Committee after many years. Cynthia Hildebrand is also thanked for her past contributions to the Committee.

# **2021 AGM BCSLA SPECIAL RESOLUTION #1** PROPOSED BYLAW AMENDMENT: ASSOCIATES

#### Background

The BCSLA Credentials Committee reviews all applications, and they make recommendations to the BCSLA Board of Directors who have the final approval of applications. The current BCSLA Bylaws define three categories of Associates of the Society: 1) BCSLA Student, 2) BCSLA Intern and 3) BCSLA Associate. The Credentials Committee recommended that the Board of Directors adopt the draft Associate Policy to provide clarity on the definitions of each of the three categories. At the January 26, 2021 Board of Directors meeting the Motion to adopt the Revised Associate Policy was approved. The language in the current Bylaws should be revised to correlate with the Revised Associate Policy. Please see the next page.

#### Discussion

The Associate Policy revisions will provide direction on how to evaluate applications from candidates who come from a varied educational and experience background. It also provides direction on how to recognize candidates with degrees and/or work experience outside the field of Landscape Architecture and recommend a reduction to the six-year work experience requirement per the Associate Policy excerpted:

	In an Unrelated Program or Field	In a Related Program or Field
Degree	One Year	Two Years
Diploma	6 months	One year (for a 2-year program)
Masters	6 months	One year
Work Experience		Up to 1 year (at a rate of 1 year for every 4 years worked)

Note #1: The amount of the reduction can be combined.

**Note #2:** It is up to the discretion of the Credentials Committee to determine the quality and relevancy of the degrees and experience earned in their recommendation of the amount of the reduction applied.

The Policy is under review by the Credentials Committee to clarify unrelated programs or field. If adopted, the amended Bylaw would not take effect until the proposed Special Resolution is filed and accepted by the BC Registrar of Companies following the 2021 AGM. At the April 27, 2021 BCSLA Board of Directors meeting, after careful consideration, the BCSLA Board of Directors approved a Motion to propose an amendment to the Bylaws. **Please see the next page for current Bylaw wording and the proposed amendments.** A complete copy of the BCSLA Bylaws is available at www.bcsla.org.

**Special Resolution #1:** That the BCSLA Bylaws be amended to clarify the BCSLA Associate entry stream.

**NB:** Special Resolutions require a vote of seventy-five percent (75%) to pass.

#### **BCSLA Associate Bylaw Excerpt (current)**

#### 2.20 Associates

The following are the categories of the Associates of the Society:

- **a. BCSLA Student:** An individual who is registered in an accredited post-secondary school Landscape Architecture program of study, may apply for recognition as an Associate of the Society, and upon acceptance by the Board and payment of all fees when due, the individual is entitled to use the designation "BCSLA Student".

Upon acceptance by the Board and payment of all fees when due, such individuals are entitled to use the designation "BCSLA Associate", receive all general communications of the Society, attend general meetings as a non-voting Associate, attend continuing education programs and sessions at BCSLA rates, and benefit from information resources of the Society available to Members. BCSLA Associates are bound by the Principles and Standards of the Society, and the Bylaws as applicable.

# **2021 AGM BCSLA SPECIAL RESOLUTION #1 (CONT.)** PROPOSED BYLAW AMENDMENT: ASSOCIATES

#### **BCSLA Associate Bylaw Excerpt - Proposed**

#### 2.20 Associates

The following are the categories and definitions of the Associates of the Society:

- **a. BCSLA Student:** An individual who is registered in an accredited post-secondary school Landscape Architecture program of study, may apply for recognition as an Associate of the Society, and upon acceptance by the Board and payment of all fees when due, the individual is entitled to use the designation "BCSLA Student".
- **b. BCSLA Intern:** An intern is an Associate who has been accepted by the Board into the admission program for Membership in the Society, meeting the following requirements:
  - i. has completed a degree in landscape architecture that is approved by the Board; or
  - ii. has been employed for six (6) years in the field of Landscape Architecture to the approval of the Board or
  - iii. has an equivalent combination of degree and employment in an allied discipline,

Upon acceptance the applicant is entitled to use the designation "BCSLA Intern".

- **c. BCSLA Pre-intern:** A Pre-intern is an Associate who is in the process of meeting all the requirements needed to apply as an Intern of the BCSLA:
- i. has been employed for less than six (6) years in the field of Landscape Architecture; or
- ii. has a degree in an allied discipline; or
- iii. work experience in a related field; or

Upon acceptance the applicant is entitled to use the designation "BCSLA Pre-intern".

Upon Acceptance by the Board and payment of all fees when due, all categories of Associates of the Society are entitled to use the appropriate designation, receive all general communications of the Society, attend general meetings as a non-voting Associate, attend continuing education programs and sessions at BCSLA rates, and benefit from information resources of the Society available to Members. BCSLA Associates are bound by the Principles and Standards of the Society, and the Bylaws as applicable.

### 2021 AGM BCSLA SPECIAL RESOLUTION #2 PROPOSED LANDSCAPE ARCHITECTURE PROJECT VI

#### Background

The Landscape Architecture Project (LAP) began in 1995 to update the Architects (Landscape) Act, BCSLA Bylaws and Code of Ethics to streamline and improve the day-to-day operation of the Society. At that time, the membership had expressed a desire to focus on the following areas:

- Advocacy develop material that would promote the BCSLA and the contributions its members make to communities throughout British Columbia.
- BCSLA Act/Bylaws continue the ongoing review and refinement of the acts, objects and Bylaws that govern the society and its members.
- Membership Review explore opportunities to expand membership in the BCSLA and continue to assess current membership needs to ensure the Society's activities reflect the interests of BCSLA members.

#### Discussion

The Bill 19: Professional Governance Act (PGA) was brought into force as of February 5, 2021. The Professional Governance Act provides a consistent governance framework for self-regulating professions that incorporates best practices of professional governance. The PGA currently governs the five regulatory bodies overseeing agrologists, applied biologists, applied science technologists and technicians, engineers and geoscientists, and forest professionals. Architecture will be included in the Act soon. BCSLA formally expressed interest in joining the PGA and it is anticipated that the application will be reviewed later this year. Bill 19: Professional Governance Act (PGA) was brought into force as of February 5, 2021.

#### Special Resolution #2

That the BCSLA allocate a maximum of \$29,880.33 from the Special Levy fund for the period 2021 to 2025 in support of the Landscape Architecture Project VI. The funds will be used at the discretion of the Board of Directors for consultants to conduct a review of Bill 49 and the issues related to: Architects (Landscape) Act, Bylaws and Standards of the Profession, labour mobility and governance. Funds may also be expended for contractors to provide legal and government relations advice as required.

NB: Special Resolutions require a vote of seventy-five percent (75%) to pass.

# **2021 AGM BCSLA SPECIAL RESOLUTION #3** TERM DEPOSIT ALLOCATIONS

#### Background

At the 2000 AGM the membership approved the idea of the purchase of a strata titled office with the requirement that the Office Space Sub-Committee return to the Board of Directors with a comprehensive business plan. The Members approved an expenditure of up to \$25,000 for the purchase of the strata-titled office. The plan was to present a purchase proposal along with the details of how the purchase would be funded and a debt management/retirement plan. The plan was to also include a detailed operating budget, which would include the "office space" expenditure item as a part of the overall operating budget of the BCSLA. This was to ensure that the significant debt obligation could be professionally managed within the framework of the BCSLA annual operating budget.

The BCSLA Office Space Sub-Committee was established in 2000 with Barry Potvin, Adrienne Brown and Tara Culham as leads on the project. They generated a detailed search criterion and reviewed several potential new office space locations. Volunteers met with the bank manager to discuss the office space purchase. A preliminary assessment of our finances indicated that the BCSLA was not able to proceed with the purchase of a strata titled office. The BCSLA continued to contribute \$3,000 annually from General Revenue to the Building Fund and associated term deposit until 2011. The 2011 Strategic Initiatives Survey indicated that less than 4% of the BCSLA Members supported the purchase of a strata titled office space as the BCSLA budget did not accommodate an office purchase due to the real estate market. On the advice of a mortgage broker the BCSLA renewed the office lease in 2020 until November 31, 2030.

#### Discussion

On April 27, 2021, the Board of Directors passed the following Motion:

MOTION #8: It was moved and seconded to reserve \$40,000 of the Emergency Fund for a) the Office Transition Program in the amount of \$20,000 and b) \$20,000 for Landscape Architecture Project VI. The balance and the related interest in the amount of approximately \$114,11.41 to be invested in a 12 Month Non-Redeemable Term at the best interest available. When the Building Fund Term Deposit matures the \$40,000 will be returned to the Emergency Fund. CARRIED

The BCSLA Building Fund Term Deposit in the amount of \$63,063.55 (plus interest) will mature on August 22, 2022. The Emergency Fund Term Deposit was maturing and needed direction prior to encumbering it for another long-term investment. The BCSLA Board of Directors are proposing that Members approve the reallocation of the BCSLA Building Fund to replenish the Emergency Fund at the end of its deposit term in 2022.

**Special Resolution #3:** That the BCSLA reallocate the Building Fund Term Deposit in the amount of \$63,063.55 (plus interest) into the Emergency Fund at expiration of the term in 2022.

**NB:** All Special Resolutions require a vote of seventy-five percent (75%) to pass.
