RESOLUTION OF THE BOARD OF EXAMINERS

Dated: November 8, 2002

EXAMINATIONS POLICY

WHEREAS the Directors of the Society are responsible for the better governance of the Society, and have approved a revised Bylaws 2002 to better reflect current legal, public and professional expectations, and

AND WHEREAS the Society has completed a one-year review process of its Bylaws and Standards of Professional Conduct in this regard, including clarified membership, admissions, compliance and continuing education bylaws, along with clarified principles and standards of professional conduct, to better protect the public interest;

AND WHEREAS the profession of Landscape Architecture in North America has collectively developed a Landscape Architecture Registration Examination, which has been reviewed, tested and adopted by the Society as a primary admission requirement for practicing membership,

AND WHEREAS a post-secondary degree in landscape architecture also requires the passing of examinations evidencing professional standards,

AND WHEREAS the administration of such examinations and related admissions program and process is in the public interest and the best interest of the profession,

AND WHEREAS the Architects (Landscape) Act, RSBC 1996 provides that the Board of Examiners will be responsible for the setting and holding of examinations for membership into the profession,

THEREFORE BE IT RESOLVED that the Board of Examiners accept the revised Bylaws 2002 regarding the setting and holding of examinations, and including,

- (a) the delegation of matters related to membership, admissions program and process, and standards to the Directors, and
- (b) the delegation of the administration of the admissions program and process to the Registrar or delegatees,

subject to the Board of Examiners retaining primary roles of final reception of members into the Society and final panel of appeal for admissions matters,

AND THAT this Resolution may be provided to the Members at the Annual General Meeting as reference document,

AND THAT the Registrar and the President of the Society are hereby authorized to sign all documents and do all things reasonably necessary to better give effect to this resolution.
