

## 2019 BCSLA & CSLA Professional Dues

At the 2010 BCSLA AGM the BCSLA Membership voted via Special Resolution to approve an annual increase in dues equal to the annual rate of inflation, based on the Consumer Price Index (CPI), across all categories every year, rounding up to the nearest dollar. As of November 23, 2018, the CPI was 2.2%. On November 23, 2018 the BCSLA Board of Directors passed a Motion to increase annual dues by 2.2% in compliance with BCSLA Bylaw 3.85. ## **2019 BCSLA & CSLA Professional Dues**

All BCSLA professional dues are due “annual in advance”, i.e. by December 31 of the preceding year. Any Member allowing dues to become delinquent shall be assessed a penalty amounting to 15% of the annual dues. ### **Payment Options**

The BCSLA is pleased to offer several options for annual professional dues payment. The BCSLA Board of Directors reviewed online payment options and determined that the online fees were very high. They will continue to review online payment options and report our findings to the Members, Associates and Affiliates.

Your professional dues and fees may be submitted as follows:

- a) Mailing your payment by cheque to the BCSLA office at the address above.
- b) Using Electronic Funds Transfer (EFT) via Interac: Log on to your Canadian financial institution mobile banking app and submit an EFT. You can use the email address at “admin@bcsla.org” and the password must be your **dues invoice number**. Your financial institution may charge you a fee. If you bank with a credit union typically the fees are waived but it depends on the individual institution.
- c) \*\*Calling the office with your Visa credit card. A 3% administrative fee applies to cover administrative costs. Due to the high cost of banking fees no other credit cards are accepted. Please see page 1 for details.
- d) Registered Landscape Architects and Landscape Architects may opt to pay by three installments using postdated cheques **only** in the amount of \$310 dated December 31, 2018, March 1, 2019, and June 1, 2019. This is a total of \$930 to cover administrative costs.

### **\*Canadian Society of Landscape Architects (CSLA) Dues**
