

## 2020 BCSLA & CSLA Professional Dues

At the 2019 BCSLA AGM the BCSLA Membership voted via Special Resolution to approve an annual increase in dues equal to the annual rate of inflation, based on the Consumer Price Index (CPI), across all categories every year, rounding up to the nearest dollar. As of October 25, 2019, the CPI was 1.9%. On October 25, 2019 the BCSLA Board of Directors passed a Motion to increase annual dues by 2.0% in compliance with BCSLA Bylaw 3.85.
