

2023 BCSLA & CSLA Professional Dues

BCSLA dues allow the BCSLA to continue to offer high-quality programs and services. At the 2010 BCSLA AGM, the BCSLA Membership voted via Special Resolution to approve an annual increase in dues equal to the annual rate of inflation, based on the Consumer Price Index (CPI), across all categories every year, rounding up to the nearest dollar (Bylaw 3.85). The intent was to maintain a good level of service and to undertake strategic investments in the growth and development of the profession using a fair and transparent process. For information on the CPI, please visit www.bankofcanada.ca. At the 2022 BCSLA AGM, the BCSLA voted via Special Resolution to amend the bylaw and allow the Board of Directors to set dues as needed. For the 2023 dues, the Board approved a 5% increase.

All BCSLA professional dues are due annually in advance, i.e., by December 31 of the preceding year. Any Member, Associate/Intern or BCSLA Affiliate allowing dues to become delinquent shall be assessed a penalty amounting to 15% of the annual dues. Payment Options

The BCSLA is pleased to offer several options for annual professional dues payment. Your professional dues and fees may be submitted as follows:

- a) Using Electronic Funds Transfer (EFT) via Interac:** Log on to your Canadian financial institution mobile banking app and submit an EFT for the full amount including dues and GST to VanCity Savings Credit Union. You must use the email address at “admin@bcsla.org” and the password must be **your dues invoice number and the letters BC (eg. “12345BC”)**. Fees may apply.
- b) Pay Pal:** Please log in to the Members website at <https://www.bcsla.org/user/login>. Follow the link "PayPal to submit your 2023 BCSLA & CSLA Professional Dues Payment". Please select your membership level and submit the form and payment as prompted. GST and other fees apply.
- c) Cheque:** Mailing your payment by cheque to the BCSLA office. Be sure to pay the full amount of the invoice including the GST.

Only Registered Landscape Architects and Landscape Architects may opt to pay by three installments using postdated cheques only in the amount of \$348 .00 dated December 31, 2022, March 1, 2023, and June 1, 2023. This is a total of \$1,044.00 to cover administrative costs.
