- Provide project management expertise and oversight for projects of staff members.

- Create the 10 year capital plan for all elements of the Parks system that encapsulates growth, renewal, quality standards, and sustainability standards
- Build consensus with internal stakeholders on the prioritization of renewal and growth investment on an annual basis
- Propose budget amounts for City Council approval
- Oversee infrastructure standards adoption for public spaces within the portfolio
