The successful candidate will assemble, research, analyze, and interpret various data relevant to planning and design programs and projects. They will prepare reports and recommendations for review, represent the Department at internal and external meetings, and establish and maintain liaison with various internal and external contacts, fostering a strong sense of teamwork and shared responsibility.

The role offers a unique opportunity for the Professional Planning Analyst to exercise conducting research, reviewing policy, writing memos and reports, and make recommendation. The successful candidate reviews existing policies and servicing strategy and make recommendations on new policy direction. This role supports project work by developing graphics, coordinates meetings, prepares agendas and takes meeting notes.
