BCSLA HISTORY & FUNCTION

Our current position as a Regulatory Body:

 Landscape Architecture—a self-regulated profession in British Columbia since April 6, 1968

The Architects (Landscape) Act:

- Establishes the BCSLA as the regulatory body: a society established to carry out the Act
- Establishes the constitution of the Board of Directors
- Establishes the constitution of the Board of Examiners
- Establishes the *authority of BCSLA to regulate membership* in the Society

- The Architects (Landscape) Act is overseen by the *Ministry of Advanced Education and Skills Training*
- BCSLA became *a member of CLARB* and began to use the Landscape Architecture Registration Exams *(LARE) in 1995*



Bill 49, The Professional Governance Act (PGA)

Passed by the B.C. Legislature and received Royal Assent on November 27, 2018

WHY?

Bill 49, The Professional Governance Act (PGA)

- Self-regulation is a *privilege* granted through legislation to protect the public interest.
- Regulated professionals have an *ethical and legal duty to put the interests of the public ahead of their own*.
- Regulated professionals are granted exclusive rights to practice certain disciplines or use certain titles.
- This system *helps the public understand who is qualified* to practice in those areas.


WHAT IS THE PROFESSIONAL GOVERNANCE ACT?

The PGA is a common framework for governance of self-regulated professions in BC

- Administered by the Office of the Superintendent of Professional Governance (OSPG)
- Under the *Ministry of Attorney General* (Justice Services Branch)

OBJECTIVES:

- legislate *best practices* for professional governance
- Provide consistent and independent oversight of professional regulators
- ensure those professions are regulated to protect the public interest





STATUS OF PGA

FIVE PROFESSIONS

CURRENTLY COVERS FIVE PROFESSIONS:

- Applied Science Technologists & Technicians of BC (Applied Science Technologists and Technicians Act)
- Association of BC Forest Professionals (Foresters Act)
- BC Institute of Agrologists (Agrologists Act)
- College of Applied Biology (College of Applied Biology Act)
- Engineers and Geoscientists of BC (Engineers and Geoscientists Act)
- More professions to be added (not just currently regulated professions), may not include LLB, MD, etc.
- The AIBC will be added in 2022



STATUS OF PGA

FIVE PROFESSIONS

CURRENTLY COVERS CAB, ASTTBC, EGBC, ABCFP, BCIA

- Applied Science Technologists & Technicians of BC (Applied Science Technologists and Technicians Act)
- Association of BC Forest Professionals (Foresters Act)
- BC Institute of Agrologists (Agrologists Act)
- College of Applied Biology (College of Applied Biology Act)
- Engineers and Geoscientists of BC (Engineers and Geoscientists Act)
- More professions to be added (not just currently regulated professions), may not include LLB, MD, etc.
- The AIBC will be added in 2022

BCSLA ACTION

- The BCSLA RRTF has been tracking the evolution of legislation impacting regulating professionals since 2018.
- Made a submission to the Professional Reliance Review in January 2018
- Written response to Regulatory Intentions Paper in March 2019
- *Two key motions* have advanced our Society's position to work towards applying to the PGA:
- ✓ 1. Special Resolution #1 of the 2019 AGM to fund continued work by the RRTF
- ✓ 2. The BCSLA Board of Directors passed motion to apply to the PGA on May 26th, 2020



REGULATORY BODY RESPONSIBILITIES

PGA: Governance: Authority & Responsibilities of Regulators

- Serve and protect the *public interest*
- Preserve *protected titles and practice*
- Govern registrants in accordance with the PGA
- Implement *internal governance* practices
- Establish *requirements for registration*
- Establish *Codes of Professional Conduct*
- Establish and *enforce standards of practice*
- * (professional misconduct, conduct unbecoming and incompetent practice)
- Ensure Professional Development
- Credentials (where applicable)
- Complaint and discipline processes



STRUCTURE OF REGULATORY BODIES

REGULATORY BODY RE-STRUCTURING

COMMITTEE STRUCTURE CHANGES

5 statutory committees for core functions

- Nominations
- Credentials
- Audit and Practice Review
- Investigations
- Discipline
- Regulatory bodies may have additional committees
- Councils and committees will require lay members
- Appoint a registrar + may appoint one or more deputy registrars

PGA 13

GOVERNANCE:

- Council: 11 councillors of which 4 are lay councillors
- Merit-based appointments to council and committees (criteria TBD)
- Term limits (3-yrs x2 and President/Vice)

CHANGES TO STRUCTURE OF BYLAWS

- Regulators *must create Bylaws*
- OSPG *reviews* Bylaws for suitability
- OSPG can amend or repeal Bylaws
- Bylaws will no longer need the approval of the registrants
- Bylaws must include:
 - Standards of professional/ethical conduct
 - Standards of competence
 - Professional development
 - Reconciliation
 - Governance, etc.





REVISED PROFESSIONAL STANDARDS

CODE OF PROFESSIONAL ETHICS AND CONDUCT

Regulatory bodies must have standards of professional and ethical conduct

- Hold paramount *public health, safety and welfare*
- Practice *legally and competently*
- Maintain *competency*
- Have regard for *government policies, plans and practices*
- Distinguish between facts, assumptions and opinions
- Avoid conflict of interests
- **Report incompetent or unethical practice** posing risk to public
- Inform clients & employers of consequences if your recommendations are overruled
- Avoid plagiarizing text, ideas or work



REVISED POLICIES

STANDARDS OF COMPETENCY

- Bylaws must provide *framework for standards of* competency
- Regulatory bodies will be required to have a mandatory continuing education program, including requirements that support Indigenous reconciliation

AREAS OF PRACTICE

- Regulatory bodies *refine and standardize categories of areas of practice over time*.
 - i.e. Landscape Architect, Registered Landscape Architect
- Registrants will self-declare areas of practice as part of annual declaration/renewal process.
 - Timing Target: Beginning with 1st fee renewal after PGA in force
- Regulatory bodies may consider greater use of restricted/specialized areas of practice, where appropriate



LEVELS OF PROTECTIONS

LEVELS OF PROTECTIONS- PGA TERMINOLOGY

- **Regulated practice-** those areas of practice regulated by the regulatory body
- **Reserved title-** use of professional title is restricted to registrants of a particular regulatory body
- **Reserved practice-** areas of practice reserved for registrants of a particular regulatory body
 - Requires the experience and technical knowledge of a professional in those specific discipline(s)
- **Specialist and/or restricted practices-** a specialized area of practice with qualifications established by a regulatory body



PUBLIC REGISTER OF PROFESSIONALS

PGA requires *register on a public website* that includes:

- The person's name and whether that person is a current or former registrant
- The category, subcategory, or class of registrant
- Limits or conditions imposed on the regulated practice
- Notations for *cancellations or suspensions*

OSPG requires **bylaws that allow for collection** (and possible publishing) of:

- Registrant areas of practice (annual declaration)
- City and/or region of registrants, with exceptions
- Business contact information for registrants
- Registrant employer information



DUTY TO REPORT

New responsibilities *for individual professionals*

Registrant duty to report:

- If...reasonable and probable *grounds to believe* a registrant *from any regulatory body under the PGA* is engaged in regulated practice that may pose a risk of:
 - Significant harm to the environment OR
 - to the *health and safety of the public* or group of people

Then: Registrant must <u>promptly</u> report to the Registrar (of the identified registrant's regulatory body)



DUTY TO REPORT

New responsibilities *for employers (and registered firms in future)*

If a person (i.e. employer or partner):

Terminates the employment of a registrant; Revokes, suspends or imposes restriction on the registrant's privileges; Dissolves partnership or association with a registrant

Because the registrant's regulated practice may pose a risk of significant harm to the environment or the health and safety of the public


> Then: Person must <u>promptly</u> report to the Registrar (of the identified registrant's regulatory body)



COMPLAINTS AND DISCIPLINE CHANGES


COMPLAINT AND DISCIPLINE PROCESS

- To be included in bylaw updates
- Principles of structure:
 - Transparency
 - Objectivity
 - o Impartiality
 - Fairness
 - o Timeliness
 - Proportionate discipline



WHAT CHANGES? WHAT DOES NOT?

CHANGES:

The Architects (Landscape) Act repealed and BCSLA functions under the PGA

STAYS THE SAME:

- BCSLA continues to regulate Landscape Architects
- Registrants still primarily interact with the BCSLA



MOST IMPORTANT BENEFITS

- Status as a profession responsible for protecting public safety and the environment in the eyes of government is secured
- Be in a position to *apply for reserved practice rights*.
- Benefit from *closer relationships with government and the other resource and design professions*.
- Regulatory body governance follows *best practices*

EFFECT ON BCSLA?

POTENTIAL IMPACTS TO BCSLA

- Governance restructuring- new Council and Committees
- Revisions of bylaws, standards, policies
- Stronger focus on protection of public interest and regulatory functions
- Expanded policies and practice reviews
- Member services focused on regulatory role
- (Future) registration of firms
- Cost/time of members as yet unknown



EFFECT ON BCSLA MEMBERS?

IMPACTS TO PROFESSIONALS (REGISTRANTS) AND INDUSTRY

- Duty to review updated bylaws and policies as/when released
- Duty to know and understand updated Codes of Professional Conduct and Practice
- Understand any *revised continuing education requirements*
- Duties to report
- Proposal and procurement impacts
- Possible voluntary commitments to support transition
- Changes to the industry
