# 14 Compelling reasons to Attend the 2009 BC Land Summit

**In 2004 the first BC Land Summit was held in Vancouver**, and very successfully brought together five professional organizations that share inter-related ties to land use in the province – landscape architects, agrologists, planners, land appraisers, and real estate professionals. There were many sessions on protecting various aspects of the land – from farmland to parks and trees, and a few presenters and attendees thought that if the conference was held again, the Land Summit could be enriched if the people who work directly with landowners to protect their land on the ground were invited to participate.

When conference planning began in 2007, the Land Trust Alliance of BC (LTABC) joined the original five as a full partner in the planning and organizing of the 2009 BC Land Summit. The LTABC is composed of local, regional, and national land trusts and conservancies located across the province, and each of the member groups have staff, board, and volunteers – many who are members of the five professional organizations. Our hope is that the conference will continue to grow to include even more organizations with a connection to the land – from archaeologists, land surveyors, and heritage professionals, to biologists, foresters, and parks and recreation professionals.

The 2009 BC Land Summit will provide a diversity of opportunities to learn, share ideas, collaborate, and network with colleagues working in land-related fields. Well ahead of the current global economic crisis, the conference Program Committee chose the theme of “A Better Future: Adapting to Change” and have created a rich program of keynotes, workshops, presentations and roundtables that address four land-related conference sub-themes: Changing Place & Space, Changing Environments, A World of Change (Growth & Globalization) and Change in Motion (Movement, Transportation & Travel).

As the title of this article suggests there are compelling reasons to attend the Land Summit, even more so as we face a year of big change on all fronts. ►

**1. THE SCOPE.** The Land Summit stretches across disciplines, sectors, and professions. It encompasses everything from rural to urban and small towns in between.

**2. THE MESSAGE.** The Land Summit moves thinking about the changes we face as land use professionals to talking collaboratively about practical solutions and addressing head-on the roadblocks and problems that are barriers to coping with change.

**3. THE BRIGHT LIGHTS.** Hear and be inspired by our leading light keynote speakers – Robert F. Kennedy Jr, Sherry Kafka Wagner, Dr. Richard Hebda, and Thomas Berger.

**4. QUALITY, NOT QUANTITY** – The Land Summit offers just over 80 speakers (Check number) all tasked with offering their perspectives and expertise on vital issues that matter right now in helping us deal with change as we plan, manage, and conserve land and communities in this province. No fluff or puff, but detail, solutions, and informed debate.

**5. VITAL TOPICS.** The program committee identified key issues that will be tackled in the sessions that include housing, carbon footprints, protecting biodiversity, food production, and the all-encompassing thorny issues of finding the highest and best land uses that will sustain communities – whether protecting it for its ecosystem goods and services, finding new uses for old sites (brownfields and urban infill), or finding and creating new land and uses for it (green roofs on top of buildings).

**6. GET INVOLVED.** The 2009 BC Land Summit is about sharing opinions, best practices, and information. The audience (you) will be a vital part of that and you are encouraged to play a full part in the sessions. The program has been designed with plenty of opportunities for networking, asking questions, following up with speakers, and breathing space to absorb what you have heard.

**7. SUSTAINABILITY IN ACTION.** As a community that has embraced sustainability on the ground, staff from the Resort Municipality of Whistler will be presenting sessions, leading walking tours, showing how they are dedicated to excellence in sustainable practices, and leading the way to helping their community see beyond 2010 and embrace the Whistler 2020 comprehensive sustainability action plan. From valley bottom to mountain top, residents, businesses, and organizations are working together to make sustainability work on the ground.

**8. LOCAL LEARNING.** The 2009 BC Land Summit is specifically devoted to BC perspectives and what is being done around our province. We have invited First Nations speakers to participate in sessions, and will hold the Closing Reception at the spectacular Squamish Li'wat Cultural Centre.

**9. PRE-CONFERENCE MOBILE WORKSHOPS.** This is your chance to get up front and behind the scenes in both Whistler and other sites in the Sea-to-Sky Corridor. The mobile workshops will use sustainable forms of transportation – walking, biking, and buses. See on the ground everything from the local farms in Pemberton that are at the roots of the Whistler 2020 Food Strategy to the Olympic Athlete's Village, the Olympic facilities, cultural facilities, local housing solutions, conservation areas, and making an independent power project work for the community – all part of the Whistler 2020 Sustainability Action Plan. Head down Highway 99 and see how Squamish and Britannia Beach are evolving from their former natural resource based economies to becoming “new” waterfront communities.

**10. PRE-CONFERENCE TRAINING SESSIONS.** Five in-depth training sessions have been set up to meet the specific interests and cross-over needs of Land Summit member organizations. Local experts will lead you through continuing education sessions on appraising land for eco-gifts, covenants for planners, food security for all, legal and tax incentives for protecting private land, and understanding the ALR and Agricultural Land Commission.

**11. THE COLOUR GREEN.** The Land Summit Greening Committee is working hard with the Conference Centre and suppliers to make this a green conference. Take the train and meet other delegates on the way there. Bring your bike and get some fresh air, exercise, and personal experience with the Valley Bikeway. Bring your own mug and help Whistler save its dishwasher for other uses.

**12. MOVING PEOPLE UP MOUNTAINS.** For the opening evening reception, delegates will ride the Whistler Mountain gondola to an elevation of 1,800 meters and gather at the Roundhouse Lodge to enjoy food, refreshments, entertainment & ongoing networking opportunities.

**13. THE PROFESSIONAL BOOK EXCHANGE.** A Greening Committee initiative. Dust off any old books you have and bring them along to the book exchange. If you have any planning and design books, training manuals, conservation, sustainability, land appraisal, climate change – whatever you have and don't need will find a new owner and you might find a classic you have been looking for.

**14. IT'S NOT TOO LATE TO REGISTER** for early-bird rates – you have until March 15. This is Whistler and hotels are used to lots of occupants in a single room. Make attending more affordable by teaming up with friends and colleagues to share a room.

# The 2009 BC Land Summit: Why a Second BC Land Summit?

I can recall that soon after beginning my masters degree in planning that one of my professors advised me that less than 5% of British Columbia is relatively flat. Further, less than 2% of our province is agricultural land. In a 1996 BC Lands publication, it was reported that only 1 % of BC or 950,000 hectares have the capability to support and grow a wide range of crops (Canada Land Inventory Classes 1 - 3).<sup>1</sup>

Clearly, these statistics alone indicate that we should have the best information and advice when considering issues relating to the use, development or conservation of our land resource in British Columbia, and should be in a strong position to collaborate with professionals and stakeholders across the spectrum of land issues and land use.

The upcoming BC Land Summit's theme is "A Better Future: Adapting to Change." It is a unique conference because it brings together the Real Estate Institute of BC, the BC Society of Landscape Architects, the Planning Institute

of BC, the BC Association – Appraisal Institute of Canada, the BC Institute of Agrol-ogists and the Land Trust Alliance of BC to hold a joint conference, rather than organizing each of our own annual conferences.

The 2009 BC Land Summit, generously supported by the Real Estate Foundation of BC and our other sponsors, builds upon the success of the first BC Land Summit that was held in 2004 in Vancouver. The Land Summit offers opportunities to learn about how other professions approach some of the critical land use issues in BC. We anticipate that you will be taking home ideas on the nature of a wide variety of issues ranging from urban design and place making, conservation, agricultural land issues, planning of regions and smaller communities, to the emerging amenity and resort communities throughout BC.

The Summit will take place over three days – May 20th, 21st, and 22nd,

2009 in Whistler, British Columbia. The Summit will be based at the TELUS Whistler

Conference Centre but will also include events and activities throughout the community of Whistler and the surrounding "Sea to Sky" region.

The BC Land Summit offers a significant increase in content with more speakers, tours and sessions as compared to our respective annual conferences, including:

With the emerging financial crisis and continuing concern with climate change, the common thread of our four themes of 'change' is quite relevant. The four themes are:

- Changing Place and Space – Communities in Transition;
- Changing Environments – Natural and Cultural Diversity;
- A World of Change – Growth and Globalization; and
- Change in Motion – Movement, Transportation and Travel.

We look forward to hearing the Summit's four keynotes speak to issues of change and land issue relevant to BC in the new context we are experiencing at this time:

**ROBERT F KENNEDY JR** – a resolute defender of the environment through legal initiatives. He is well acquainted with British Columbia environmental issues due to his many visits to our Province. In addition to being an author of my books and articles and a Professor of Environmental Law at Pace University, Mr. Kennedy serves as senior attorney for the Natural Resources Defense Council, Chief Prosecuting Attorney for the Hudson Riverkeeper and is President of the Water-keeper Alliance.

**SHERRY KAFKA WAGNER** – a high profile urban designer focusing on place making and cultural institutions. She has played an instrumental role, in many projects, including the creation of the San Antonio Riverwalk, the Dallas Texas Arts District and the Charles River Basin Park, Wharf District Parks and the Tennessee Aquarium in Chattanooga. Most important, Sherry is a great story teller and her address will certainly prove to have a remarkable number of antic dots that provide insight into her observations.

**THOMAS BERGER OC OBC** – first emerged as a national figure in the 1970's as the Commissioner for Mackenzie Valley Pipeline Inquiry. He has continued to play a central role in governance issues as well as a continuing high profile role in a series of Commissions and Inquiries on a variety of resource and First Nations issues. For 12 years he served as a Justice of the Supreme Court of British Columbia.

**DR. RICHARD HEBDA** – will provide you with a commentary on the impact of climate change on our forests and plant life in British Columbia. For more than 28 years, he has been the curator of Botany and Earth History for the Royal Columbia Museum. He is the author of many scientific and popular articles on the impact of climate change on native plants. Most recently he has been the Province of B.C.'s expert on Metro Vancouver's Burn's Bog.

His Honour Steven Point, Lieutenant Governor of British Columbia, along with other dignitaries, will be welcoming you to the Summit. The program also includes the participation of speakers from British Columbia's First Nations.

Roundtables sessions, are an opportunity for exploration and participatory debate among several high profile panelists and will focus on the following issues:

- Government as Developer: What is the Role of Governments & Public Agencies in Shaping Land Development in BC?: Moderated by Don Alexander, Professor of Geography, Vancouver Island University;
- The Global Financial Crisis and its Impacts on Land, Land Use Policies and Development in BC: moderated by Michael Geller, Vancouver planner and developer, and former CEO of the Simon Fraser University Community Trust;
- Examining 35 Years of the Agricultural Land Commission & The Islands Trust in BC: moderated by Erik Karlsen, Chair of the Agricultural Land Commission;
- Highway to Where? Transportation Choices and Land Use Consequences: moderated by Gordon Price, Director of the Simon Fraser University City Program.

Of course, Whistler will provide a memorable setting for the Summit. On Wednesday, May 20th there will be a variety of optional intensive workshops, as well as walking tours exploring the development, history, parks and facilities in the Whistler area – including facilities built for the 2010 Olympic Winter

Games. In addition, there will be other mobile workshops or tours where you can explore learn in the surrounding communities and natural areas of the Sea-to-Sky region.

There will also be a series of social and networking receptions in remarkable locations including the Roundhouse Lodge on Whistler Mountain and the spectacular new Squamish Lil'wat Cultural Centre. Continental Breakfasts and lunches are also included with your registration.

The 2009 BC Land Summit offers exceptional conference value for money, with a rich and diverse program included within an affordable registration fees. 


